2023 PREA Annual Report

INTRODUCTION

In 2023, The GEO Group, Inc. received a total of 461 allegations of sexual abuse and harassment involving detainees, residents, and inmates. The report includes data from 60 secure and non-secure residential facilities and provides information regarding the types and outcomes of these allegations, as well as the measures taken to prevent and respond to incidents of sexual misconduct.

REPORTING PERIOD

As required by the Prison Rape Elimination Act (PREA), Pub. L. No. 108-79 (2003), The GEO Group, Inc. (GEO) has collected and reviewed data on allegations reported from January 1, 2023, through December 31, 2023. GEO produced this report in compliance with 28 C.F.R. § 115.87-89. This data was collected through the review of the following information:

- Information entered by PREA compliance managers in GEO's PREA database; and,
- Reports/investigations from GEO's Office of Professional Responsibility (OPR).

In 2023, there were a total of 461 allegations that met the definitions of sexual abuse or harassment. This report reflects the status of 2023 allegations as of June 3, 2024. As of June 3, 2024, 55 of 461investigations remained on-going from the calendar year 2023. Of the 55 on-going investigations, 55 are being conducted by outside law enforcement agencies.

POLICY SUMMARY²

GEO mandates zero tolerance towards all forms of sexual abuse and sexual harassment in all its facilities. It is GEO's policy that sexual conduct between employees, volunteers, or contractors and inmates/detainees/residents, regardless of consensual status, is prohibited and subject to administrative, criminal, and disciplinary sanctions. Personal identifiers were omitted from this report to ensure the safety and security of staff and individuals housed in our facilities.

GEO FACILITIES COVERED THIS REPORT (60 FACILITIES)

This report contains PREA data collected from all GEO Facilities covered by DOJ PREA Standards. It does not contain PREA data collected from GEO facilities housing Immigration Customs Enforcement (ICE) detainees, as these facilities fall under the Department of Homeland Security (DHS) PREA Standards and data from these facilities will be reported as required by DHS. This report includes a comparison of 2022 and 2023 data as required by PREA Standard §115.88 - Data review for corrective action.

The following 60 facilities are covered in this report:

- 25 U.S. Secure Services facilities
- 35 Residential Reentry Centers

GENERAL DEFINITIONS⁴

- **Contractor**: a person who provides services on a recurring basis pursuant to a contractual agreement with the agency.
- **Detainee**: any person detained in a lockup, regardless of adjudication status.
- Employee: a person who works directly for the agency or facility.
- Inmate: any person incarcerated or detained in a prison or jail.
- On-going (OG): investigation has not been completed.
- Resident: any person confined or detained in a juvenile facility or in a community confinement facility.
- Staff: employees⁵.
- Substantiated (SUB): an allegation that was investigated and determined to have occurred.
- Unfounded (UF): an allegation that was investigated and determined not to have occurred.
- **Unsubstantiated (UNSUB)**: an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.
- **Volunteer**: an individual who donates time and effort on a recurring basis to enhance the activities and programs of the agency.

DEFINITIONS RELATED TO SEXUAL ABUSE & HARASSMENT⁶


Sexual Abuse

- (1) Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident; and
- (2) Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer.

Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident includes any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent or refuse:

- (1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and the penis, vulva, or anus;
- (3) Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and
- (4) Any other intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation.

Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer includes any of the following acts, with or without consent of the inmate, detainee, or resident:





- (1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;
- (2) Contact between the mouth and the penis, vulva, or anus;
- (3) Contact between the mouth and any body part where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (4) Penetration of the anal or genital opening, however slight, by a hand, finger, object, or other instrument, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (5) Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;
- (6) Any attempt, threat, or request by a staff member, contractor, or volunteer to engage in the activities described in paragraphs (1)-(5) of this section;
- (7) Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an inmate, detainee, or resident, and
- (8) Voyeurism by a staff member, contractor, or volunteer.

Voyeurism by a staff member, contractor, or volunteer means an invasion of privacy of an inmate, detainee, or resident by staff for reasons unrelated to official duties, such as peering at an inmate who is using a toilet in his or her cell to perform bodily functions; requiring an inmate to expose his or her buttocks, genitals, or breasts; or taking images of all or part of an inmate's naked body or of an inmate performing bodily functions.

Sexual Harassment

- (1) Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate, detainee, or resident directed toward another; and
- (2) Repeated verbal comments or gestures of a sexual nature to an inmate, detainee, or resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures.

INCIDENT TYPE ACRONYMS

The following acronyms are used by GEO to track reported allegations of sexual abuse and harassment:

- IISA Inmate-on-Inmate or Detainee-on-Detainee Sexual Abuse

EVIDENTIARY STANDARD

The agency shall impose no standard higher than a preponderance of the evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated.⁷

In 2023, there were 461 allegations in the four incident types listed above.⁸ Every allegation was referred for investigation and a total of 59 allegations, 39 sexual abuse and 20 sexual harassment, were substantiated. All cases involving staff were received, assessed, and processed by GEO's Office of Professional Responsibility. When criminal activity was suspected, GEO referred the allegations of sexual abuse or sexual harassment to an agency with the legal authority to conduct criminal investigations.⁹

- GEO received 461 allegations in 2023, an increase from 411 in 2022. This is an increase of 50 allegations.
- U.S. Secure Services received 382 allegations in 2023, an increase from 350 in 2022. This is an increase of 32 allegations.
- Reentry Services received 79 allegations in 2023, an increase from 61 in 2022. This is an increase of 18 allegations.

- There were 59 substantiated allegations GEO-wide in 2023, an increase from 36 in 2022. This is an increase of 23 substantiated allegations.
- There were 38 substantiated allegations for U.S. Secure Services in 2023 an increase from 23 in 2022. This is an increase of 15 substantiated allegations.
- There were 21 substantiated allegations for Reentry Services in 2023, an increase from 13 in 2022. This is an increase of 8 substantiated allegations.

- There were 207 IISA allegations reported to GEO in 2023, an increase from 135 in 2022 to 207 in 2023. This is an increase of 72 IISA allegations.
- There were 189 IISA allegations reported to U.S. Secure Services in 2023, an increase from 122 in 2022 to 189 in 2023. This is an increase of 67 allegations.
- There were 18 IISA allegations reported to Reentry Services in 2023, an increase from 13 in 2022 to 18 in 2023. This is an increase of 5 IISA allegations.

- There were 92 IISH allegations reported to GEO in 2023, an increase from 90 in 2022. This is an increase of 2 IISH allegations.
- There were 73 IISA allegations reported to U.S. Secure Services in 2023, a decrease from 77 in 2022. This is a decrease of 4 IISH allegations.
- There were 19 IISH allegations reported to Reentry Services in 2023, an increase from 13 in 2022. This is an increase of 6 IISH allegations.

- There were 91 SISA allegations reported to GEO in 2023, a decrease from 106 in 2022. This is a decrease of 15 SISA allegations.
- There were 65 SISA allegations reported to U.S. Secure Services in 2023, a decrease from 81 in 2022. This is a decrease of 16 SISA allegations.
- There were 26 SISA allegations reported to Reentry Services in 2023, an increase from 25 in 2022. This is an increase of 1 SISA allegation.

- There were 71 SISH allegations reported to GEO in 2023, a decrease from 80 in 2022. This is a decrease of 9 SISH allegations.
- There were 55 SISH allegations reported to U.S. Secure Services in 2023, a decrease from 70 in 2022. This is a decrease of 15 SISH allegations.
- There were 16 SISH allegations reported to Reentry Services in 2023, an increase from 10 in 2022. This is an increase of 6 SISH allegations.

2023 PROGRAM ENHANCEMENTS

Actions in 2023:

In 2023, GEO implemented the following actions to enhance the prevention and detection of any incidents and to enhance responses to allegations of sexual abuse and sexual harassment:

• Corporate Contract Compliance Department Enhancements

- Monthly PREA Training sessions were conducted by PREA subject matter experts to PREA compliance managers, specialized investigators, and compliance staff. These sessions covered a variety of PREA topics are covered, with a different focus each month.
- Collaborated with the PREA Resource Center (PRC) to participate in a training exercise at one of GEO's secure services facilities. The exercise aimed to foster a working partnership and for the PRC to evaluate their PREA auditing program.

• Training and education of employees, contractors and volunteers

- Employees, contractors, and volunteers received annual PREA in-service training as required by GEO policies in 2023.
- Thirty employees from U.S. Secure Services and Residential Reentry Centers received PREA Specialized Investigations Training in 2023.
- Approximately 100 U.S. Secure Services and Residential Reentry Center staff attend and receive standardspecific PREA training monthly.

Assessment of Physical Plant Issues at Facilities

- Annual PREA Facility Assessments were conducted in all GEO U.S. Secure Services and Residential Reentry Centers to identify areas needing improvement to enhance the company's ability to protect individuals from sexual abuse and sexual harassment. All recommendations for enhancements were submitted and reviewed by the corporate PREA coordinator and appropriate divisional authority. For example, to reduce blind spots and enhance surveillance monitoring:
 - Eleven facilities recommended adding or updating camera surveillance monitoring systems.
 - One facility added fifteen cameras.
 - Four facilities recommended adding dome mirrors.
 - Two facilities improved their process for distributing PREA materials to inmates upon intake.
 - One facility enhanced their specialized PREA training curriculum for employees.
 - One facility enhanced their PREA investigative processes to ensure the timely completion of investigations.
 - One facility enhanced their processes for identifying and monitoring inmates that may be potentially at risk of victimization.
