# 2024 PREA Annual Report

## **INTRODUCTION**

In 2024, The GEO Group, Inc. received a total of 489 allegations of sexual abuse and harassment involving detainees, residents, and inmates. The report includes data from 59 secure and non-secure residential facilities and provides information regarding the types and outcomes of these allegations, as well as the measures taken to prevent and respond to incidents of sexual misconduct.

#### **REPORTING PERIOD**

As required by the Prison Rape Elimination Act (PREA), Pub. L. No. 108-79 (2003), The GEO Group, Inc. (GEO) has collected and reviewed data on allegations reported from January 1, 2024, through December 31, 2024.<sup>1</sup> GEO produced this report in compliance with 28 C.F.R. § 115.87-89. This data was collected through the review of the following information:

- Information entered by PREA compliance managers in GEO's PREA database; and,
- Reports/investigations from GEO's Office of Professional Responsibility (OPR).

In 2024, there were a total of 489 allegations that met the definitions of sexual abuse or harassment. This report reflects the status of 2024 allegations as of June 2, 2025. As of June 2, 2025, 47 of 489 investigations remained on-going from the calendar year 2024. Of the 47 on-going investigations, 47 are being conducted by outside law enforcement agencies.

#### POLICY SUMMARY<sup>2</sup>

GEO mandates zero tolerance towards all forms of sexual abuse and sexual harassment in all its facilities. It is GEO's policy that sexual conduct between employees, volunteers, or contractors and inmates/detainees/residents, regardless of consensual status, is prohibited and subject to administrative, criminal, and disciplinary sanctions. Personal identifiers were omitted from this report to ensure the safety and security of staff and individuals housed in our facilities.

## GEO FACILITIES COVERED THIS REPORT (59 FACILITIES)

This report contains PREA data collected from all GEO Facilities covered by DOJ PREA Standards. It does not contain PREA data collected from GEO facilities housing Immigration Customs Enforcement (ICE) detainees, as these facilities fall under the Department of Homeland Security (DHS) PREA Standards and data from these facilities will be reported as required by DHS. This report includes a comparison of 2023 and 2024 data as required by PREA Standard § 115.88 - Data review for corrective action.

The following 59 facilities are covered in this report:

- 25 U.S. Secure Services facilities
- 34 Residential Reentry Centers

#### **GENERAL DEFINITIONS<sup>4</sup>**

- **Contractor**: a person who provides services on a recurring basis pursuant to a contractual agreement with the agency.
- **Detainee**: any person detained in a lockup, regardless of adjudication status.
- Employee: a person who works directly for the agency or facility.
- Inmate: any person incarcerated or detained in a prison or jail.
- **On-going (OG)**: investigation has not been completed.
- Resident: any person confined or detained in a juvenile facility or in a community confinement facility.
- **Staff**: employees.<sup>5</sup>
- Substantiated (SUB): an allegation that was investigated and determined to have occurred.
- Unfounded (UF): an allegation that was investigated and determined not to have occurred.
- **Unsubstantiated (UNSUB)**: an allegation that was investigated and the investigation produced insufficient evidence to make a final determination as to whether or not the event occurred.
- **Volunteer**: an individual who donates time and effort on a recurring basis to enhance the activities and programs of the agency.

## DEFINITIONS RELATED TO SEXUAL ABUSE & HARASSMENT<sup>6</sup>

#### • Sexual Abuse

(1) Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident; and

(2) Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer.

Sexual abuse of an inmate, detainee, or resident by another inmate, detainee, or resident includes any of the following acts, if the victim does not consent, is coerced into such act by overt or implied threats of violence, or is unable to consent or refuse:

(1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;

(2) Contact between the mouth and the penis, vulva, or anus;

(3) Penetration of the anal or genital opening of another person, however slight, by a hand, finger, object, or other instrument; and

(4) Any other intentional touching, either directly or through the clothing, of the genitalia, anus, groin, breast, inner thigh, or the buttocks of another person, excluding contact incidental to a physical altercation.

Sexual abuse of an inmate, detainee, or resident by a staff member, contractor, or volunteer includes any of the following acts, with or without consent of the inmate, detainee, or resident:

(1) Contact between the penis and the vulva or the penis and the anus, including penetration, however slight;

(2) Contact between the mouth and the penis, vulva, or anus;

(3) Contact between the mouth and any body part where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(4) Penetration of the anal or genital opening, however slight, by a hand, finger, object, or other instrument, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(5) Any other intentional contact, either directly or through the clothing, of or with the genitalia, anus, groin, breast, inner thigh, or the buttocks, that is unrelated to official duties or where the staff member, contractor, or volunteer has the intent to abuse, arouse, or gratify sexual desire;

(6) Any attempt, threat, or request by a staff member, contractor, or volunteer to engage in the activities described in paragraphs (1)-(5) of this section;

(7) Any display by a staff member, contractor, or volunteer of his or her uncovered genitalia, buttocks, or breast in the presence of an inmate, detainee, or resident, and

(8) Voyeurism by a staff member, contractor, or volunteer.

Voyeurism by a staff member, contractor, or volunteer means an invasion of privacy of an inmate, detainee, or resident by staff for reasons unrelated to official duties, such as peering at an inmate who is using a toilet in his or her cell to perform bodily functions; requiring an inmate to expose his or her buttocks, genitals, or breasts; or taking images of all or part of an inmate's naked body or of an inmate performing bodily functions.

#### Sexual Harassment

(1) Repeated and unwelcome sexual advances, requests for sexual favors, or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one inmate, detainee, or resident directed toward another; and

(2) Repeated verbal comments or gestures of a sexual nature to an inmate, detainee, or resident by a staff member, contractor, or volunteer, including demeaning references to gender, sexually suggestive or derogatory comments about body or clothing, or obscene language or gestures.

## **EVIDENTIARY STANDARD**

The agency shall impose no standard higher than a preponderance of the evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated.<sup>7</sup>

In 2024, there were 489 allegations in the four incident types listed above.<sup>8</sup> Every allegation was referred for investigation and a total of 59 allegations, 32 sexual abuse and 27 sexual harassment, were substantiated. All cases involving staff were received, assessed, and processed by GEO's Office of Professional Responsibility. When criminal activity was suspected, GEO referred the allegations of sexual abuse or sexual harassment to an agency with the legal authority to conduct criminal investigations.<sup>9</sup>

- GEO received 489 allegations in 2024, an increase from 453 in 2023. This is an increase of 36 allegations.
- U.S. Secure Services received 412 allegations in 2024, an increase from 375 in 2023. This is an increase of 37 allegations.
- Reentry Services received 77 allegations in 2024, a decrease from 78 in 2023. This is a decrease of 1 allegation.

In 2022, there were total of 411 allegations reported, which rose by approximately 10% to 453 allegations in 2023. Most recently, in 2024, there was a 8% increase in allegations from 2023, totaling 489 allegations. All allegations with suspected criminal activity are referred to an agency with the legal authority to conduct criminal investigations. <sup>9</sup> The percentage of SISA allegations related to pat searches increased from 2023 to 2024. In 2023, 15 of 91 (16%) SISA allegations were related pat searches. In 2024, this increased to 22 of 97 (23%). All SISA allegations related to pat searches were investigated, and two were substantiated.

- There were 59 substantiated allegations GEO-wide in 2024, a decrease from 64 in 2023. This is a decrease of 5 substantiated allegations.
- There were 44 substantiated allegations for U.S. Secure Services in 2024, an increase from 41 in 2023. This is an increase of 3 substantiated allegations.
- There were 15 substantiated allegations for Reentry Services in 2024, a decrease from 23 in 2023. This is a decrease of 8 substantiated allegations.

- There were 242 IISA allegations reported to GEO in 2024, an increase from 202 in 2023. This is an increase of 40 IISA allegations.
- There were 213 IISA allegations reported to U.S. Secure Services in 2024, an increase from 184. This is an increase of 29 allegations.
- There were 29 IISA allegations reported to Reentry Services in 2024, an increase from 18 in 2023. This is an increase of 11 IISA allegations.

- There were 87 IISH allegations reported to GEO in 2024, a decrease from 91 in 2023. This is a decrease of 4 IISH allegations.
- There were 80 IISA allegations reported to U.S. Secure Services in 2024, an increase from 72 in 2023. This is an increase of 8 IISH allegations.
- There were 7 IISH allegations reported to Reentry Services in 2024, a decrease from 19 in 2023. This is a decrease of 12 IISH allegations.

- There were 97 SISA allegations reported to GEO in 2024, an increase from 92 in 2023. This is an increase of 5 SISA allegations.
- There were 70 SISA allegations reported to U.S. Secure Services in 2024, an increase from 65 in 2023. This is an increase of 5 SISA allegations.
- There were 27 SISA allegations reported to Reentry Services in 2024, no change from 27 in 2023.

- There were 63 SISH allegations reported to GEO in 2024, a decrease from 68 in 2023. This is a decrease of 5 SISH allegations.
- There were 49 SISH allegations reported to U.S. Secure Services in 2024, a decrease from 54 in 2023. This is a decrease of 5 SISH allegations.
- There were 14 SISH allegations reported to Reentry Services in 2024, no change from 14 in 2023.

## 2024 PROGRAM ENHANCEMENTS

#### Actions in 2024:

In 2024, GEO implemented the following actions to enhance the prevention and detection of any incidents and to enhance responses to allegations of sexual abuse and sexual harassment:

#### • Corporate Contract Compliance Department Enhancements

 Monthly PREA training sessions were provided by subject matter experts to PREA compliance managers, specialized investigators, and compliance staff. Each session focused on a distinct PREA-related topic, providing ongoing professional development and reinforcing best practices to ensure we provide consistent, high-quality services at all facilities.



- Attended the National PREA Coordinator's Conference in Buffalo, NY, gaining valuable insights and best practices to strengthen institutional compliance and enhance sexual safety practices. Participated in the National PREA Coordinators Working Group quarterly meetings, fostering collaboration and knowledge-sharing with PREA professionals nationwide to support continuous improvement and alignment with national standards.
- Promoted Sexual Assault Awareness Month across all facilities through coordinated awareness activities and educational materials, fostering a culture of prevention, support, and zero tolerance for sexual abuse.

#### • Training and education of employees, contractors and volunteers

- Employees, contractors, and volunteers received annual PREA in-service training as required by GEO policies in 2024.
- Twenty-four employees from U.S. Secure Services and Residential Reentry Centers received PREA Specialized Investigator's Training in 2024.
- Approximately 80 U.S. Secure Services and Residential Reentry Center staff attend and receive standard-specific PREA training monthly.

#### • Assessment of Physical Plant Issues at Facilities

- Annual PREA Facility Assessments were conducted in all GEO U.S. Secure Services and Residential Reentry Centers to identify areas needing improvement to enhance the company's ability to protect individuals from sexual abuse and sexual harassment. All recommendations for enhancements were submitted and reviewed by the corporate PREA coordinator and appropriate divisional authority. Examples of enhancements include:
  - Ten facilities initiated the process of upgrading their video surveillance systems.
  - Three facilities supplemented their PREA training program with additional material.
  - One facility added an additional 16 cameras to enhance monitoring and eliminate blind spots.
  - One facility added barriers between the restroom toilets in the dormitory area.
  - One facility installed emergency phones on the floor programmed to dial a direct line in the security booth in the event of an emergency.
  - One facility upgraded their communications system through the purchase of new staff radios.
