a. Identify the community-based organization(s) or victim advocates with whom you communicated:

The facility has attempted to enter into an MOU with TESSA to provide emotional support services. On 3/26/25 contact was made with the Advocacy Manager of TESSA to discuss services TESSA provides. TESSA has a 24/7 crisis hotline called Safeline. Paid and volunteer advocates and interns answer Safeline calls, after they complete 35 hours of Victim Advocacy training. Calls to Safeline are not recorded and callers can remain anonymous upon request. A contract with Language Line Services provides translation for non-English speaking callers. If a caller reports an allegation of sexual abuse, the advocate will walk the caller through options of self-reporting. TESSA provides advocates to accompany victims through the forensic exam procedure. An advocate is available at the UC Health Hospital during normal business hours. After hours Safeline is called for call-out availability of an advocate to be dispatched to the hospital. Follow-up services are provided within 24-48 hours after the forensic exam and again one month later. TESSA has a clinical team comprised of Social Workers and Psychologist for further follow-up as needed. There is also an advocate at the court house during business hours to help victims fill out paperwork related to Orders of Protection. All services are confidential and provided at no cost to the victim.

The interview of the agency's PREA Coordinator and the Agency Head Designee were conducted at the beginning of this reaccreditation period. Two contractors and three volunteers were interviewed by telephone during the Pre-Onsite Audit Phase.

During the site review, the locations of cameras, mirrors, room layout, restrooms and placement of PREA posters and information was observed. All showers have curtains for privacy and toilets have partitions with walls in front of the toilet areas. All residents interviewed stated they feel they have privacy to shower, toilet and change clothing and that they feel safe from sexual abuse at this facility.

Facility notices in English and Spanish were posted in various areas of the facility with the date posted noted as 1/24/25. Resident Reporting Options posters were posted in all housing units and in numerous areas throughout the facility. Cameras were noted in hallways, common areas, bay dorms and the exterior of the facility. The facility has 56 interior and 11 exterior cameras. Four servers are located in a small room adjacent to the Security Office. DVR's retain camera footage from 30-65 days, depending on the location of the camera. Camera monitors, located in the Security Office, were reviewed and found to be in working order and prohibits opposite gender viewing. Signs on all housing unit doors remind staff to make opposite gender announcements. These announcements were observed during the site review and residents interviewed confirmed opposite gender staff always announce themselves before entering housing or restroom areas.

The majority of residents have their personal cell phones, but the facility has three PREA phones available for residents to make PREA calls. One is located in the Conference Room, male day room and Tranquility hallway. On the first day of the audit, the numbers to the DOC TIPS Line, Tessa and Diversus were called on one of the PREA phones. All numbers were found to be accessible. On the first day of the audit, the PREA risk screening for one newly assigned resident was observed. The resident was screened in a room with the door closed and the screener asked the resident the screening questions

and informed the resident where the PREA phones were located and where the resident could find posted PREA information. The resident was given a *PREA Education Manual for Residents and* signed an acknowledgement form that he received the manual.

The facility has a contract with Language Line Services for translations of any languages. The number to Language Line Services was called and found to be accessible. During the review 16 residents and 4 staff were informally interviewed questioning them about their knowledge of the zero-tolerance policy and methods available to them of reporting allegations of sexual abuse and sexual harassment. A total of 24 residents were formally interviewed.

Twenty-four resident records were selected and reviewed to determine compliance with screening procedures and PREA education for residents. The facility had two allegations of inmate-on-inmate sexual abuse in the past 12 months. The investigative files of those allegations were reviewed. All 53 staff human resource files and PREA training files were reviewed (see the narrative for standard 115.217 for details). Human Resource files were reviewed remotely during the Pre-Onsite Audit Phase.

Zero tolerance of sexual abuse and sexual harassment; PREA coordinator

Auditor Overall Determination: Exceeds Standard

Auditor Discussion

115.211 (a): GEO policy 5.1.2, Zero Tolerance Policy Towards Sexual Abuse and Harassment, is the written agency policy mandating zero tolerance towards all forms of sexual abuse and sexual harassment and outlines the agency's approach to preventing, detecting and responding to such conduct. Other agency policies include 5.1.2-A, PREA Sexually Abusive Behavior Intervention Procedure and 5.1.2-E, PREA Investigation Procedures (non-ICE). Facility policies define the procedures that are used at the Community Alternatives of El Paso County (CAE) and guidance for adherence to the PREA standards and the agency policies. Facility policies include the following: 2019-1, PREA Staffing and Facility Requirements; 2019-2, PREA Intake and Orientation; 2019-3, PREA Screening/Admission; 2019-4, Resident Searches, Viewing, and Contraband; 2019-5, Grievance Process; and 2019-6, Sexual Abusive Behavior Prevention and Intervention Program (PREA). Agency policies include definitions of prohibited behaviors and sanctions for those found to participate in these prohibited behaviors. The agencies policies are comprehensive and clearly outline the procedures to be followed to reduce and prevent sexual abuse and sexual harassment of residents. The policies address each standard as

guidance to staff ensuring compliance to the PREA standards and were found to exceed in the requirements of this standard.

115.211 (b) GEO policy 5.1.2-A, pages 6 & 7, section III, B, 1-3 and facility policy 2019-1, pages 2 & 3, section VI-A, outline the responsibilities of the PREA Coordinator and the PREA Compliance Manager. The agency's organizational chart depicts the PREA Coordinator's position within the agency. The Assistant Director, Programs is designated as the facility's PREA Compliance Manager (PCM). The facility's Organizational Chart depicts the PREA Compliance Manager's position. The PREA Coordinator oversees the agency's efforts to comply with the PREA standards in all GEO facilities. The agency not only employs an agency-wide PREA Coordinator, but also employs a Director, Fidelity & Quality Assurance who provides oversight to the agency's reentry facilities; therefore, exceeding in the requirements of this provision of this standard.

In interview with the agency's PREA Coordinator at the beginning of this reaccreditation period he stated, "Yes, I have sufficient time and authority to develop, implement and oversee the agency's efforts to comply with the PREA standards at all GEO facilities". When asked how he coordinates the agency's efforts to comply with the PREA standards he stated. "I supervise a corporate PREA compliance team consisting of four PREA Compliance Managers (PCMs) and a PREA Compliance Specialist. There is also one PREA division coordinator and three regional PREA Compliance Managers that assist with the Reentry Services division. Furthermore, each of the corporate PREA Compliance Managers on my team have investigative oversight for each of their assigned facility and serve as the main point of contact for all PREA-related questions".

When asked if he identifies an issue with complying with a PREA standard, what actions would he take to work toward compliance with the standard the PREA Coordinator he stated, "The agency conducts annual audits to identify any issues with compliance. The results of the internal audits are thoroughly reviewed during the post audit workshop and a corrective action plan is developed. In addition, our internal auditing tools are reviewed/updated annually to include methodologies for maintain compliance and improving overall quality. In conjunction with the corporate PCM's we utilize the PREA Resource Center for up-to-date guidance and as a resource for standard interpretation. We also provide the PREA "Standards in Focus" to the facility PCM's as a resource for implementing best practices. Our specialized investigator training format is an interactive (trackable) web-based curriculum that is updated annually. Additionally, we have a web-based specialized investigator refresher training and a PCM orientation guide which are also updated annually."

When interviewed the Assistant Director, Programs/PCM stated she has sufficient time and authority to coordinate the facility's efforts to comply with the PREA standards as required. The agency's policies were found to be very comprehensive and both the PREA Coordinator and the Assistant Director, Programs/PCM were very knowledgeable when interviewed. The agency also employees a PREA Division Coordinator and three regional PREA Compliance Managers at the corporate level that assist with the Reentry Services division; therefore, the facility was found to

exceed in the requirements of this standard.

	115.212: GEO is a private provider and does not contract with other agencies for the confinement of residents; therefore, this standard is not applicable.

115.213 Supervision and monitoring

Auditor Overall Determination: Exceeds Standard

Auditor Discussion

115.213 (a): Based on GEO policy 5.1.2-A, pages 3 & 4, section C-1 and facility policy 2019-1, pages 3 & 4, section B-1, the agency has developed and documented a staffing plan that provides for adequate levels of staffing and uses video monitoring to protect residents against sexual abuse. The agency took into consideration the physical layout of the facility, the composition of the population and the prevalence of substantiated incidents of sexual abuse, and the resources the facility has available to commit to ensure adequate staffing levels in the development of the facility's staffing plan. The facility's design capacity is 270 residents, and the staffing plan was developed based on that number. In the past 12 months, the average daily population was 221 residents. When interviewed the Facility Director stated, that the staffing plan allows for adequate staffing levels and video monitoring is part of the plan.

The agency's PREA Coordinator responded to how facilities assess adequate staffing levels and the need for video monitoring equipment when developing facility staffing plans as follows:

a. The physical layout of each facility:

"We fully understand the intent and language within the PREA guidelines. GEO has a zero tolerance for any sexual abuse within our facilities and does everything possible to design and run facilities which protect inmates from abuse. Since the release of the federal standards, we have allocated funds for shower modifications, camera upgrades, etc. and will continue to consider these enhancements during new construction projects as well."

"We acquire facilities which are at times older in construction and not optimal by today's standards. Our company leadership allocated the resources needed to

make proper modifications to enhance safety." "Our corporate PREA team works very closely with our corporate project development team. If design issues are detected during internal or external site visits, we use a team approach to address and correct the issue."

b. The composition of the resident population:

"GEO routinely uses new technology to assist in better monitoring of our staff and inmates within our facilities. We routinely add or improve camera coverage within our prisons and jails. New technology is added to screening areas to control contraband and assist in maintaining the safety of our facilities."

"Corporate operations staff routinely meet with vendors to look for more efficient and effective ways to bolster security and safety within our facilities".

c. The prevalence of substantiated and unsubstantiated incidents of sexual abuse:

"GEO monitor incidents at both the local and national level to identify patterns and areas for improvement. The monitoring has been made possible through software applications and systems implemented nationally allowing incidents and audit results to be tracked and compared more easily."

d. Any other relevant factors:

"Security monitoring systems, the PREA portal, software applications, improvements in communication technology such as radios, emergency response practices, afteraction reviews, and audit findings are all taken into consideration. Again, our corporate PREA team works closely with our corporate project development team. If design issues are detected during internal or external visits, we use a team approach to address and correct the issue."

115.213 (b): The facility makes its best efforts to comply with the approved PREA Staffing Plan. In circumstances where the staffing plan is not complied with, the Facility Director would document and justify all deviations from the plan. The Facility Director when interviewed stated a daily roster by month is developed by the Assistant Director, Security and he reviews the rosters for compliance. In review of documentation provided by the facility and upon interview with the Facility Director, in this audit period there were no times that there were deviations to the staffing plan. The staffing plan is designed to provide a minimum-security staff-to-resident ratio of 50:1, with one female and male Monitors and a 20:1 ratio for case management staff at any given time. The facility has an on-call schedule in the event of approved time off and call outs to ensure there are no deviations from the established staffing plan.

115.213 (c) Whenever necessary or at least once a year the staffing plan is reviewed. The staffing plan is reviewed annually by the Facility Director, Assistant Facility Director of Programs/PREA Compliance Manager, and the Assistant Facility Director-Programs and are documented on the *Annual PREA Facility Assessment*-

Reentry form. This form is then forwarded to the Regional Director, the Director, Fidelity & Quality Assurance, the Divisional Vice President and the Corporate PREA Coordinator for signature and approval of any recommendations made to the established staffing plan to include the deployment of video monitoring systems and other monitoring technologies or the allocations of additional resources to maintain compliance to the plan. In the 2023 and 2024 PREA Annual Facility Assessments provided for review, no recommendations were made for changes to the established staffing plan. In interview of the PREA Coordinator he stated, "Each facility is required to conduct an Annual PREA Facility Assessment, which requires them to review their staffing plan and all components of the physical plant. Completed assessments are forwarded to me which include recommendations for equipment, cameras, additional staffing, etc. I review and consult with the appropriate divisional leadership (i.e., secure services and reentry services) and we assess the request. It is either approved or denied, signed and returned to the facility."

According to agency policy 5.1.2-A, page 4, section C-1-f, facilities implement a policy and practice requiring higher-level supervisors (facility management staff) and intermediate-level supervisors (shift supervisors or assistant shift supervisors) to conduct and document unannounced PREA rounds in all areas and on all shift to identify and deter employee sexual abuse and sexual harassment. Shift Supervisors conduct rounds during their shift and these rounds are documented on the Post Order form. There are three counts per shift, which are documented on the Housing Count Roster. Program Monitors are required to make at a minimum, four random walk-throughs per shift. Management staff and mid-level Supervisors are required to complete, at a minimum, unannounced PREA rounds once a shift each month. These rounds are documented on the PREA Unannounced Supervisor Rounds form. Employees are prohibited from alerting residents or other employees that these supervisory rounds are occurring. The PREA Unannounced Supervisor Rounds forms for the months of February and March 2025 were provided for review. Unannounced PREA rounds are being conducted as required and, in both months reviewed, the number of rounds conducted on each security shift exceeded the required amount.

Documentation provided for review, and review of *PREA Unannounced Supervisor Rounds* forms while on site and in interview with staff and residents, the practice of rounds by facility management staff and supervisory staff confirmed numerous rounds being conducted on all three shifts. The facility was found to exceed in its monitoring efforts.

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.215 (a): Based on review of GEO policy 5.1.2-A, page 12, section I, and facility policy 2019-4, pages 2 & 3, sections 1-3, the facility prohibits cross-gender strip searches and cross-gender visual body cavity searches except in exigent circumstances or when performed by medical practitioners. Facility policy requires that all cross-gender strip searches and body cavity searches be documented. Resident strip searches and body cavity searches are prohibited at the Community Alternatives of El Paso (CAE). If at any time there is cause to strip search a resident, the Facility Director or designee will contact the nearest correctional institution to arrange and have search conducted at the local institution. In the past 12 months, there were no cross-gender strip or cross-gender visual body cavity searches performed.

- 115.215 (b): Females are not restricted access to regular available programming or outside opportunities in order to comply with this provision. At all times, there is a female and a male staff member on duty. Random staff interviewed confirmed there is always a male and female staff on duty. In interview of five female residents, they reported there is always a female staff available to pat search them.
- 115.215 (c): The facility would document all cross-gender strip searches and cross-gender visual body cavity searches if they were to occur in an exigent circumstance. All pat searches are conducted in an area adjacent to the Security Office in view of a camera.
- 115.215 (d): The agency has policies and procedures in place that enable residents to shower, perform bodily functions and change clothing without staff viewing their breast, buttocks or genitalia. Policy requires staff of the opposite gender to announce their presence when they enter resident housing and restroom areas. Signs are on all resident rooms reminding staff to make opposite gender announcements. This practice was observed while on-site and residents and staff interviewed confirmed that this practice is being followed. All residents are required to change clothing in the resident restroom area. In the event a staff has observed an opposite-gender resident for any reason, the staff member is responsible for making an immediate report and submitting a written statement describing the circumstances that resulted in the incident. This report must be submitted to the Facility Director prior to the end of the employee's shift. Residents interviewed shared opposite gender staff make an announcement before entering their housing units and they feel they have privacy to shower, toilet and change clothing when opposite gender staff are in their housing units.
- 115.215 (e): Based on GEO policy 5.1.2-A, pages 12 & 13, section J-3 and facility policy 2019-4, page 3, section D-4, the facility prohibits examining transgender or intersex residents for the sole purpose of determining genital status. If the resident's genital status is unknown, it may be determined during conversations with the resident, by reviewing the medical records, or, if necessary, by a medical

examination conducted in private by a medical practitioner. In interview of random staff, they knew that this was prohibited by policy. Transgender and intersex residents complete a *Statement of Search Preference Form* indicating what gender of staff they would like to pat search them. In the past 12 months there were no transgender or intersex residents assigned to the facility.

115.215 (f): In addition to general training provided to all employees, security staff receive training on how to conduct cross-gender pat-down searches and searches of transgender and intersex residents. The agency's *Guidance in Cross Gender and Transgender Pat Searches* curriculum was provided for review. Staff sign a *Prison Rape Elimination Act (PREA) Training Acknowledgement* form upon completion of PREA training. Receipt of this training was verified through interviews with staff and review of 24 staff PREA training records.

115.216

Residents with disabilities and residents who are limited English proficient

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.216 (a): The agency takes appropriate steps to ensure that residents with disabilities and residents that are limited English proficient have an opportunity to participate and benefit from all aspects of the agency's efforts to prevent, detect and respond to sexual abuse and sexual harassment. GEO policy 5.1.2-A, page 10, section E and facility policy 2019-2, page 3, were used to verify compliance to this standard. In interview with the Director, Quality Assurance and Reentry Services (agency head designee), "All GEO facilities have developed PREA education materials in various formats to ensure that individuals with disabilities and those who are limited English proficient can equally benefit from the PREA program. GEO has developed posters, pamphlets, videos and large print materials, etc. and provides access to TTY phones, language lines and designated staff interpreters to ensure we can effectively communicate procedures and available services to residents. Facilities also reach out to community-based resources (i.e., local colleges or organizations) that might be willing to assist." The facility has a TTY which is stored in the Assistant Director, Programs/PCM's office and available for staff use. The facility has a contract with Language Line Services and sign language interpretation is included in the contract. At the time of the onsite audit visit there were no residents who were identified as deaf, hard of hearing, blind, with low vision, or with physical disabilities.

115.216 (b): Residents receive a *PREA Education Manual for Residents* during the intake process that is available in English, Spanish and in large print for residents with low vision. PREA posters are provided in both English and Spanish. Seven staff members are identified as proficient in the Spanish language and provide interpretation to Spanish speaking residents. A contract with Language Line

Services provides for the translation of any other languages and includes sign language interpretation. At the time of the onsite audit visit there were 11 residents identified as limited English proficient (LEP) assigned to the facility. Three LEP (Spanish) residents were interviewed. Two LEP residents when interviewed stated they did not need translation and were able to understand the questions asked of them. The third LEP resident was interviewed with translation provided by the Food Service Manager. The telephone number for Language Line Services was dialed and found to be accessible for staff use.

115.216 (c): The agency prohibits the use of resident interpreters, resident readers or other types of resident assistants except in limited circumstances. In the past 12 months, there have been no instances where residents were used for these purposes. Random staff interviewed knew the use of resident interpreters was not allowed. Limited English proficient residents interviewed said staff always interpret for them.

115.217 Hiring and promotion decisions

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.217 (a): GEO policy 5.1.2-A, page 8 section C-2 and facility policy 2019-1 page 4, section B-2, interview with the Human Resource Manager, and review of all employee files were used to verify compliance to this standard. Per policy the agency/facility prohibits hiring or promoting anyone who may have contact with residents and prohibits enlisting the services of any contractor who may have contact with residents who have engaged in, been convicted of, or been civilly or administratively adjudicated for engaging in sexual abuse in confinement settings or in the community.

115.217 (b): GEO and the facility considers any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents. Interview with the Human Resource Manager confirmed this practice.

115.217 (c): The agency requires all applicants and employees who may have contact with residents to complete a criminal background check. In interview with the Human Resource Manager, she shared that criminal background checks for all potential employees are completed through a contract with Accurate Backgrounds, in addition to a background check by the Colorado Department of Public Safety, Office of Community Corrections. For those considered for promotions or who transfer from another facility, an internal background check through GEO, is requested on the (HR-104), and an Accurate background check is conducted. If an applicant answers on their application, they were a prior institutional employee,

information from prior institutional employers is requested through Accurate Backgrounds. From information provided on the Pre-Audit Questionnaire, in the past 12 months, 35 criminal background checks were conducted for new hires. The documentation revealed criminal background checks were conducted on all applicants as part of the hiring process. Four of the 18 records reviewed were employees promoted in the past 12 months. Internal criminal background checks were conducted through GEO and an Accurate background check performed.

During the initial request of documentation,18 employee human resource files were requested for review. Due to the facility's inability to either locate or in some cases materials were missing, 10 additional employee records were selected for review, for a total of 28 employee human resource files. Following completion of my review, conversations were held with the Human Resource Manager and the agency's Manager, Contract Compliance, to discuss my findings and steps needed to be taken to achieve compliance to this standard. The agency's Manager, Contract Compliance advised the Human Resource Manager to perform a complete file review of all employee files to confirm whether or not missing documentation could be located or if follow-up was needed.

115.217 (d): The agency requires all contractors and volunteers have criminal background checks before enlisting their services. The facility has two contractors and seven volunteers. In review of the files of the two contractors and three of the volunteers, criminal background checks were conducted prior to enlisting their services.

115.217 (e): Criminal background checks are conducted on all employees and contractors through Accurate Backgrounds every five years. Ten of the 53 human resource files reviewed were employees who had been employed for greater than five years. Two employees employed for greater than five years had five-year background checks conducted late. One employee's five-year criminal background check was conducted after seven years and one after eight years from dates of their previous five-year background checks. One of the contractors who has provided services for more than five years showed a five-year background check was conducted as required.

115.217 (f): The agency asks all applicants and employees who have contact with residents directly about previous sexual misconduct. Applicants are asked these questions on the GEO application. For consideration for promotions or transfers, employees complete a PREA Disclosure and Authorization Form Promotions – PREA Related Positions (PREA-102). Annually at the time of performance evaluations, employees sign a PREA Disclosure and Authorization – Annual Performance Evaluations (PREA-101). On information provided from the facility and in interview with the Human Resource Manager, in the past 12 months there were seven promotions and no transfers. At the time the records were requested to be reviewed, three of the employees promoted were no longer assigned to the facility. The remaining four employee records of those promoted within the past 12 months were reviewed. One of the four records did not have a PREA Disclosure and Authorization Form Promotions – PREA Related Positions (PREA-102). Of the

remaining employee records reviewed, initially several PREA-101's were not found filed in the appropriate facility personnel records. The Human Resource Manager was able to find all missing forms with the exception of three PREA Disclosure and Authorization – Annual Performance Evaluations (PREA-101). A suggestion was made to the Human Resource Manager to develop a tracking form for this information to ensure all PREA 101's are completed.

During the exit meeting on the second day of the audit, the Human Resource Manager reported she had adjusted her employee roster with a new log for QA purposes to track background check information and disclosures. During the Post-Onsite Audit Phase, I reviewed the remaining 25 employee files that I had not reviewed prior to the onsite audit visit. A few PREA 101's were missing and the Human Resource Manager was able to find all missing documentation, with the exception of one PREA 101 for 2023. When sharing the findings of my review of all employee human resource files with the Director, Fidelity & Quality Assurance (Reentry Services), he reported the agency will be working with the Human Resource Manager on developing a calendar system linked to their email which will provide notification via email for upcoming annual performance evaluations and serve as a reminder to complete the employee's PREA Disclosure and Authorization - Annual Performance Evaluations (PREA-101) forms and 5-year background check due dates. The Director, Fidelity & Quality Assurance reported the Manager, Program Performance will follow-up with the Human Resource Manager within 30 days post-audit to review requirements of the provisions of this standard and assist with enabling the electronic calendar system.

115.217 (g): GEO and the facility policy mandates that material omissions regarding sexual misconduct and the provision of materially giving false information are grounds for termination as required by this standard. Employees have a continuing affirmative duty to disclose any sexual misconduct.

115.217 (h): Unless prohibited by law, GEO's Reentry Services Human Resource Department will provide information on substantiated allegations of sexual abuse or sexual harassment involving a former employee upon receiving a request from an institutional employer for whom the individual has applied for work.

Due to the steps the facility and the agency has taken to ensure compliance to all requirements of all provisions of this standard and the processes in place for continued compliance, the facility was found to achieve compliance to this standard.

	115.218 (a): GEO policy 5.1.2-A, page 8, section C-3, facility policy 2019-1, page 4, section 3, interview of the Facility Director and documentation provided for review

was used to verify compliance to this standard. Per agency and facility policies, Arapahoe County Residential Center shall consider the effect any new design, acquisition, expansion or modification of physical plant or monitoring technology might have on the facility's ability to protect residents from sexual abuse. In interview with the Director, Quality Assurance and Reentry Services (agency head designee) he stated, "GEO is a world leader in providing sound and effective security measures in the facilities we manage and operate. Every facility acquired by the company is thoroughly assessed for needed safety and security enhancements in both physical plant construction and procedure enhancement. When GEO acquires older facilities that are not optimal by today's standards, security modifications are prioritized to enhance safety. When modifications are made by GEO to existing institutions, or when new facilities are designed and constructed, the design/construction staff work closely with GEO's experienced operational personal to significantly improve the safety of our institutions. GEO routinely merges operational and design expertise in the enhancement of facilities. The security and safety of residents and staff are at the forefront of every decision made by the company. GEO has a zero-tolerance for any sexual abuse within facilities and does everything possible to design and operate facilities that protect residents from abuse. Since the release of the federal standards, GEO has not only allocated funds to shower modifications, camera upgrades, etc. in existing facilities but also considers these enhancements during new construction projects as well. The corporate PREA team works very closely with the Corporate Project Development team. If design issues are detected during internal or external site reviews, a team approach is used to address and correct the issues." In interview with the Facility Director and on information provided on the Pre-Audit Questionnaire, since the last PREA audit the facility has not acquired any new facilities and has not had any substantial expansions or modifications to the existing facility.

115.218 (b): When installing or updating a video monitoring system GEO considers how the technology may enhance the agency's ability to protect residents from sexual abuse. In interview with the Director, Quality Assurance and Reentry Services (agency head designee) he stated, "GEO routinely uses new technology to assist in better monitoring of staff and residents within our facilities. GEO routinely adds or improves camera coverage within our centers. New technology is added to screening areas to control contraband and assist in maintaining the safety of our facilities. Corporate Operations staff routinely meet with vendors to look for efficient and effective ways to bolster security and safety within our facilities. The company implemented software applications and systems nationally that track audit results and events. These applications assist in the comparison of audit results and events. Those applications assist in the comparison of audit results and events to identify patterns and areas is need of improvement. Again, the Corporate PREA team works very closely with our Corporate Project Development team. If design issues are detected during internal or external site visits, we use a team approach to address and correct the issues." In interview with the Facility Director, on information provided on the Pre-Audit Questionnaire and the most current Annual PREA Facility Assessment - Reentry (9/1/24), since the last PREA audit, all cameras

were updated to high-definition. An additional four DVR's and 16 cameras were added. The camera vendor assessed angles, moved some cameras and installed different types of cameras with a larger field of view in the large bays.

115.221 Evidence protocol and forensic medical examinations

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.221 (a): GEO policy 5.1.2-E, pages 5-8, sections D-I and facility policy 2019-6, pages 8-10, sections C-3 & 4, outlines the agency's requirements as it applies to this standard. The Assistant Director, Programs/PCM and the Assistant Director, Security are trained facility investigators responsible for administrative investigations of sexual abuse and sexual harassment at the Community Alternatives of El Paso County. The Colorado Springs Police Department is responsible for conducting criminal investigations and to ensure all forensic evidence is collected and preserved in accordance with evidence protocols established by the Department of Justice (DOJ). The investigating entities follow a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence and fulfill all requirements of this standard. In interview of random staff, they knew how to preserve evidence and knew who the facility investigators were that were responsible for conducting administrative investigations of allegations of sexual abuse and sexual harassment.

The facility has made attempts to secure an MOU with the Colorado Spring Police Department. To date those efforts have been unsuccessful. On 3/21/25, the Sargeant of the Special Victims Unit of the Colorado Springs Police Department was contacted to discuss the process in the event of a sexual assault at the Community Alternatives of El Paso facility. The facility is located in the jurisdiction of the Police Department and are responsible for investigating all crimes that occur in their jurisdiction. When notified of a sexual assault, a Patrol Officer would be dispatched to the facility to gather information for an initial report. Depending on the level of the offense would depend on how the Police Department proceeds. If the assault involved staff, a detective from the Special Victims Unit would definitely be assigned to investigate the allegation. In the case of an allegation of resident-on-resident sexual abuse, their response would be determined by the facts of the case. Victims of sexual abuse would be transported to Memorial Hospital for a SANE exam. Every 60 days the detective assigned to the case would contact the victim to inform him/ her of the status of the investigation. The facility can contact the detective at any time. A copy of the completed criminal investigative report can be requested through the Public Information Act.

115.221 (b): The protocol is developmentally appropriate for youth where

applicable and, as appropriate, shall be adapted from or otherwise based on the most recent edition of the Department of Justice's Office on Violence Against Women publication. "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents" or similarly comprehensive and authoritative protocols developed after 2011.

115.221 (c): Victims of sexual abuse have access to forensic medical examinations with the victim's consent and without cost to the resident regardless of if the victim names the abuser or cooperates with an investigation arising out of incident. Forensic exams are not performed at this facility. Victims of sexual abuse are referred to the Memorial Hospital for SANE exams at no cost to the resident. In the past 12 months, there have been no residents who have required SANE exams.

115.221 (d): TESSA provides a crisis hotline 24 hours a day, victim advocacy services, counseling and referrals. In interview with the agency's PREA Coordinator he stated, "GEO policy requires each facility each facility to pursue a Memorandum of Understanding (MOU) with a community-based provider capable of providing victim advocacy services. In the event an MOU cannot be obtained, the facility is required to document the attempt to enter into an MOU and/or maintain documentation that no other alternatives are available in the community. If no alternatives are available, an agency staff member is screened for appropriateness to serve as an advocate and trained on the provision of victim advocacy services. Agency staff training is documented and maintained as part of the staff member's official training record. Each facility ensures the rape crisis center provides the following: 24-hour hotline services; accompaniment and advocacy through medical, criminal and support systems; crisis intervention services to include individual and group support services; information and referrals to assist the victim; communitybased services and the development/distribution of materials related to available services."

On 3/21/35, the Clinical Manager, SANE/SAFE Project Director was contacted to discuss forensic exam services offered to victims of sexual assault. The Forensic Nurse Examiner Team is available at the Memorial Central Emergency Department 24/7. An advocate from TESSA would be dispatched to the hospital to accompany the victim through a SANE exam. Victim would be offered STD prophylaxis if the assault occurred in the past two weeks. Any longer than two weeks, the victim would be tested for STD's and offered prophylaxis if necessary. Female victims of childbearing age are given pregnancy tests and offered emergency contraception. Forensic exams are performed at no cost to the victim. Any medical services necessary due to the assault can be covered by the Victims Compensation Fund.

The facility has made several attempts to enter into a Memorandum of Understanding (MOU) with Memorial Central Hospital. An e-mail from the Clinical Manager to the Program Fidelity Specialist from Community Alternatives of El Paso County was referenced during the telephone conversation. The Clinical Manager reported she has not received a draft of the MOU as she requested on 12/6/24 in her e-mail. E-mail correspondence provided by the facility showed an e-mail from the Program Fidelity Specialist to the Clinical Manager on 12/9/24 showing the MOU was

attached. The Clinical Manager said she did not receive that e-mail and requested it be resent. This information was shared with the Program Fidelity Specialist. (The Program Fidelity Specialist reported during the Entrance Meeting of the onsite audit visit, that the MOU was sent to the Clinical Manager as requested.)

The facility has attempted to enter into an MOU with TESSA to provide emotional support services. On 3/26/25 contact was made with the Advocacy Manager of TESSA to discuss services TESSA provides. TESSA has a 24/7 crisis hotline called Safeline. Paid and volunteer advocates and interns answer Safeline calls, after they complete 35 hours of Victim Advocacy training. Calls to Safeline are not recorded and callers can remain anonymous upon request. A contract with Language Line Services provides translation for non-English speaking callers. If a caller reports an allegation of sexual abuse, the advocate will walk the caller through options of selfreporting. TESSA provides advocates to accompany victims through the forensic exam procedure. An advocate is available at the UC Health Hospital during normal business hours. After hours Safeline is called for call-out availability of an advocate to be dispatched to the hospital. Follow-up services are provided within 24-48 hours after the forensic exam and again one month later. TESSA has a clinical team comprised of Social Workers and Psychologist for further follow-up as needed. There is also an advocate at the courthouse during business hours to help victims fill out paperwork related to Orders of Protection. All services are confidential and provided at no cost to the victim.

115.221 (e): Residents are made aware of the confidential emotional support services available to them in the *PREA Education Manual for Residents*, page 10 and on PREA posters displayed throughout the facility. When interviewed, residents were aware of the confidential emotional support services available to them and how to access them. In interview of the agency's PREA Coordinator he stated, "GEO policy requires each facility to ensure residents are offered access to a community-based provider capable of providing emotional support, crisis intervention, information, and referrals during the forensic medical examination process and investigatory interviews. In the event a community-based provider is unavailable, an agency staff member is trained on the provision of victim advocacy services."

115.221 (f): The Assistant Director, Programs/PCM and the Assistant Director, Security are responsible for conducting administrative investigations of allegations of sexual abuse and sexual harassment. Criminal investigations are conducted by the Colorado Springs Police Department.

115.222	Policies to ensure referrals of allegations for investigations

	115.222 (a): GEO policy 5.1.2-A, pages 1 & 2, section II-A-3, GEO policy 5.1.2-E,

pages I & 2, section II-A-1 and facility policy 2019-6, pages 15 & 16, section 11 outline the agency's policy and procedures for investigating and documenting incidents of sexual abuse and sexual harassment. The agency ensures that an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment, including resident-on-resident sexual abuse or staff sexual misconduct. In interview with the Director, Quality Assurance and Reentry Services (Agency Head Designee) he stated, "An administrative and/or criminal investigation of all allegations of sexual abuse or harassment is required by GEO corporate and local facility policies. Based on client contract requirements, an investigation would be conducted by either the client investigative unit, local law enforcement (if criminal) or a trained GEO facility investigator." He further stated, "GEO has a cadre of staff in the reentry division that have received PREA Specialized Investigations Training. Reentry services also utilize local, state or federal agencies to investigate these type allegations, based on client contract requirements. All PREA allegations are documented and referred to an agency with the legal authority to conduct criminal investigations unless the allegation does not involve criminal behavior."

115.222 (b): Upon receipt of an allegation of sexual abuse, the supervisor receiving the report immediately notifies the Facility Director. The Facility Director will make immediate notification to the PREA Coordinator, to the Director, Fidelity & Quality Assurance, to GEO's Office of Professional Responsibility (OPR if the allegation involved staff), and to the client. The facility initiates an administrative investigation and if it is determined that the allegation involves potential criminal activity, a referral is made to the Colorado Springs Police Department who conducts a criminal investigation. The facility has made attempts to secure an MOU with the Colorado Spring Police Department. To date those efforts have been unsuccessful. On 3/21/25, the Sargeant of the Special Victims Unit of the Colorado Springs Police Department was contacted to discuss the process in the event of a sexual assault at the Community Alternatives of El Paso facility. The facility is located in the jurisdiction of the Police Department and are responsible for investigating all crimes that occur in their jurisdiction. When notified of a sexual assault, a Patrol Officer would be dispatched to the facility to gather information for an initial report. Depending on the level of the offense would depend on how the Police Department proceeds. If the assault involved staff, a detective from the Special Victims Unit would definitely be assigned to investigate the allegation. In the case of an allegation of resident-on-resident sexual abuse, their response would be determined by the facts of the case. Victims of sexual abuse would be transported to Memorial Hospital for a SANE exam. Every 60 days the detective assigned to the case would contact the victim to inform him/her of the status of the investigation. The facility can contact the detective at any time. A copy of the completed criminal investigative report can be requested through the Public Information Act.

It is the responsibility of the Colorado Springs Police Department to ensure that all forensic evidence is collected and preserved in accordance with evidence protocols established by the Department of Justice. In interview of the facility investigators, they knew their responsibility of referring any allegations that appear to be criminal

to the Colorado Springs Police Department. The agency documents all referral of allegations of sexual abuse or sexual harassment for criminal investigation. A Serious Incident Report is completed for all allegations of sexual abuse. All allegations are tracked on the PREA Monthly Incident Outcome Tracking Log.

115.222 (c): The agency policy regarding the referral of allegations of sexual abuse or sexual harassment for criminal investigation is published on the GEO website http://www.geogroup.com/reporting_sexual_abuse-prea. In the past 12 months, there were two allegations of inmate-on-inmate sexual abuse reported and administratively investigated. There were no allegations referred for criminal investigation.

115.231 Employee training

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.231 (a): GEO employees receive training on GEO's zero-tolerance policy (5.1.2) for sexual abuse and sexual harassment at pre-service and annually at in-service. Training includes Prison Rape Elimination Act (PREA) and Guidance in Cross-Gender and Transgender Pat Searches. The agency's requirement of this training is found on page 9, section F-1 of GEO policy 5.1.2-A. Between trainings, the facility has monthly staff meetings where PREA is often reviewed and discussed. The PREA training curriculums were reviewed and found to address all elements of 115.231 (a) as required by this standard. The Assistant Director, Programs/PCM provides staff PREA training to new hires during pre-service training. Employees complete annual in-service PREA training requirements online through a program called Absorb. In interview of staff, they confirmed completing PREA training annually and confirmed what the training entailed.

- 115.231 (b): The training is tailored to meet the needs of male and female residents. Employees who are reassigned from facilities housing only one gender of residents are given additional training to meet the needs of the opposite gender population.
- 115.231 (c): In interview with staff, they were able to confirm receiving PREA training and knew their responsibilities for preventing and responding to allegations of sexual abuse and sexual harassment.
- 115.231 (d): Employees sign a *Prison Rape Elimination Act (PREA) Training Acknowledgement* form (attachment E of GEO policy 5.1.2-A), acknowledging they have received and understood the training. Documentation of annual PREA training for employees is maintained in employee human resource files. In review of the PREA training records of all 53 assigned facility staff, some records did not contain Prison Rape Elimination Act (PREA) Training Acknowledgment forms, but completion of training was verified for most employees on electronic training reports for those

that have been employed any years through this reaccreditation period (2023, 2024 and 2025). In discussion with the Human Resource Manager, she felt the reason some forms were missing was because employees are completing the online PREA training because their names are on the electronic reports, but they are not downloading and printing the training acknowledgement form or not turning it in to their supervisors. It was recommended to the facility that employees be retrained on the procedure to follow upon completion of the in-service PREA training to ensure the *Prison Rape Elimination Act (PREA) Training Acknowledgment* forms are printed and submitted as required by policy 5.1.2-A.

115.232 Volunteer and contractor training

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.232 (a): GEO policy 5.1.2-A states that all contractors and volunteers shall receive training on the agency's policy on zero tolerance for sexual abuse and sexual harassment. Guidelines on volunteer training can be found on page 10, section G-1, and contractor training on page 11, section H-1. The facility has two contractors and eight volunteers. The Assistant Director, Programs/PCM is responsible for training contractors and volunteers annually.

115.232 (b): The training curriculum *Sexually Abusive Behavior Prevention and Intervention Program (PREA) Orientation and Training 2017* was provided for review. Contractors and volunteers are trained on their responsibilities under GEO's sexual abuse and harassment prevention, detection and response policies and procedures including their responsibility and method of reporting any knowledge, suspicion or information regarding an incident of sexual abuse or sexual harassment.

115.232 (c): The Assistant Director, Programs/PCM maintains contractor and volunteer training files. Contractors and volunteers sign a *Prison Rape Elimination Act (PREA) Basic Training Acknowledgement* form acknowledging that have received and understood the training provided to them. In review of two contractor and three volunteer training records, documentation was complete. In interview with the two contractors and three of the volunteers they confirmed receiving PREA training and knew their responsibilities in reporting allegations of sexual abuse and sexual harassment.

115.233 Resident education Auditor Overall Determination: Exceeds Standard Auditor Discussion

115.233 (a): Based on GEO policy 5.1.2-A, pages 8 & 9, section E-2 and facility policy 2019-2, pages 3 & 4, all residents receive information at time of intake and if transferred from another facility about the zero-tolerance policy and how to report incidents of sexual abuse or sexual harassment, their rights to be free from retaliation for reporting such incidents and are informed of the agency policy and procedures for responding to such incidents. Security Monitors provide residents with written and verbal PREA information upon intake. Residents interviewed confirmed receiving written and verbal PREA information on the first day of arrival to the facility. Security Monitors interviewed confirmed what PREA information is provided to residents upon intake.

115.233 (b): Residents who transfer from another community confinement facility receive the same PREA education as all residents assigned to the facility. In information provided on the Pre-Audit Questionnaire, in the past 12 months there were no residents who transferred from a different community confinement center.

115.233 (c): Resident education is presented in formats accessible to all residents. On information provided on the Pre-Audit Questionnaire, in the past 12 months, 447 residents assigned to the facility received PREA education within the first 24 hours of arrival. Upon intake to the facility residents receive a *PREA Education Manual for Residents* that is available in English, Spanish and in large print. In reporting numbers on the last page of the *PREA Education Manual for Residents*, were called. One of the numbers to the DOC TIPS Line and the number to Diversus Health were numbers for recorded advertising. Other numbers on that page were to the Memorial Hospital SANE program and TESSA's administration offices. It was recommended that page be replaced with the Reporting Options Poster. On the second day of the audit, the manual was revised by the Fidelity Specialist.

Spanish speaking staff are available for Spanish translation and a contract with Language Line Services is used for the translation of any other languages. All posted PREA information is posted in English and Spanish. In interview of 24 residents, all residents confirmed receiving PREA information on the first day of arrival to the facility.

115.233 (d): Residents acknowledge by their signature on a *Prison Rape Elimination Act (PREA) Resident Manual Acknowledgement* form that they have received a copy of the *PREA Education Manual for Residents*. They also sign *PREA Training Acknowledgement* form acknowledging receipt of training on the zero-tolerance policy, their right to report and their right to free medical and mental health care. During the Pre-Onsite Audit Phase, it was recommended to the facility that the *PREA Training Acknowledgement* form be revised. The form included acknowledgement of the resident of viewing the *PREA: What You Need to Know video*. The facility does not show the video any longer. Reference to the video was also included on page 4 of facility policy 2019-2. A revision was made to the policy and reference to the PREA video was removed from the policy. The Assistant Director, Programs/PCM maintains documentation of PREA education to residents.

115.233 (e): Ongoing PREA information is provided on numerous posters, both in

English and Spanish, found displayed in various locations throughout the facility, including in all resident rooms and common areas. The Facility Director and the Assistant Director, Security hold monthly Town Hall Meetings with residents where PREA is often discussed.

In review of 24 residents' files, documentation of PREA education was found filed for all residents and the dates signed on the required forms showed residents receive PREA education on their day of arrival to the facility. When interviewed, residents were knowledgeable of the zero-tolerance policy and the methods of reporting available to them. It was evident that the facility has done an excellent job of informing residents of the zero-tolerance policy and makes PREA information continuously accessible. The facility was found to exceed in the requirements of this standard.

115.234 | Specialized training: Investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.234 (a): Based on GEO policy 5.1.2-A, page 10, section F-3, in addition to general education provided to all employees, GEO ensures that facility investigators receive training on conducting sexual abuse investigations in confinement settings in addition to general PREA training provided to all employees. At the Community Alternatives of El Paso County, the Assistant Director, Security and the Assistant Director, Programs/PCM are the trained facility investigators. The Assistant Director, Security was not interviewed as she was not onsite during the onsite audit visit due to illness. When interviewed, the Assistant Director, Programs/PCM confirmed completing specialized investigations training and was knowledgeable of her responsibilities in conducting sexual abuse and sexual harassment administrative investigations.

115.234 (b): Facility investigators complete *PREA Specialized Training Investigating Sexual Abuse in Adult/Juvenile Correctional Settings*. In review of the training curriculum, the training includes techniques for interviewing sexual abuse victims, proper use of the Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings and the criteria and evidence required to substantiate a case for administrative action or referral for prosecution. In interview, the Assistant Director, Programs confirmed the topics addressed in the training.

115.234 (c): The facility maintains documentation that the investigators have received specialized training. The facility provided certificates of completion of specialized training and *Prison Rape Elimination (PREA) Basic Training Acknowledgement* forms showing the investigators complete general PREA training that all employees are required to complete.

Auditor Overall Determination: Meets Standard Auditor Discussion 115.235 (a): According to GEO policy 5.1.2-A, pages 9 & 10, section F-2, in addition to general training provided to all employees, GEO ensures all full and part-time Qualified Health Care Professionals and Qualified Mental Health Professionals, who work regularly in their facilities shall specialized medical training. The Community Alternatives of El Paso County does not employ medical or mental health staff; therefore, this standard is not applicable to this facility. All medical and mental health services are provided by referral to off-site providers.

115.241 Screening for risk of victimization and abusiveness

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.241 (a): Based on GEO policy 5.1.2-A, pages 5 & 6, section D-1 and facility policy 2019-3, pages 2 & 3, section B, all offenders placed at the Community Alternatives of El Paso County facility are assessed for their risk of being sexually abused or sexually abusive towards others upon arrival to the facility. Security Monitors are responsible for conducting the initial screenings. In addition to the screening form, a thorough review of any available records that can assist in determining risk assessment is completed. Interview of Security Monitors confirmed all residents are screened upon admission to the CAE.

115.241 (b): According to GEO policy 5.1.2-A, intake screening is conducted within 24 hours of a resident's arrival to the facility, exceeding in the 72-hour requirement of this provision of this standard. In information provided on the Pre-Audit Questionnaire, in the past 12 months, 442 residents assigned to the facility were screened upon arrival for their risk of sexual victimization and sexual abusiveness. Twenty-four residents formally interviewed and 16 residents informally interviewed confirmed they were screened upon intake to the facility. The Assistant Director, Programs/PCM and Security Monitors interviewed described the screening process. On the first day of the audit visit, I observed the PREA portion of the intake process of one resident. A Security Monitor conducted the initial screening in a private room with the door closed. He asked the resident the screening questions, provided the resident with a PREA Education Manual for Residents and informed the resident where the PREA phones were located and where he could find reporting information, followed by the resident given an opportunity to ask any questions.

115.241 (c): Initial screenings are conducted using the *Reentry Facilities PREA Risk* Assessment Tool, an objective screening tool.

115.241 (d): The form was reviewed and found to contain all requirements of provision 115.241 (b) of this standard.

115.241 (e): The initial screening considers prior acts of sexual abuse, prior convictions for violent offenses, and history of prior institutional violence or sexual abuse in assessing residents for risk of being sexually abusive, as confirmed by interview of the Assistant Director, Programs/PCM and two Security Monitors responsible for initial screenings.

115.241 (f): Within a set time, not to exceed 30 days of the resident's arrival to the facility, Case Managers using the *PREA Vulnerability Reassessment Questionnaire* (HWH 38) reassess residents for their risk for victimization and abusiveness. According to information provided on the Pre-Audit Questionnaire, in the past 12 months 442 residents assigned to the facility whose length of stay was over 30 days were reassessed for their risk of victimization or abusiveness. In review of 24 resident records to determine compliance with screening procedures, one 30-day *PREA Vulnerability Reassessment Questionnaire* was conducted six days after the 30-day required date. All other screenings reviewed were conducted on or before the 30-day due date.

115.241 (g): A resident's risk level will also be reassessed when warranted due to a referral, request, incident of sexual abuse, or receipt of additional information. The Assistant Director, Programs/PCM and Case Managers maintain *Reentry Facilities PREA Risk Assessment Tool* and *PREA Vulnerability Reassessment Questionnaires* in their offices.

115.241 (h): Residents are not disciplined for refusing to answer or for not disclosing complete information in response to questions asked on the screening form.

115.241 (i): GEO implements appropriate control of risk screening information. In interview with the PREA Coordinator he stated, "Access to a resident's risk assessment is limited to those requiring the information to make housing, work assignments and program/education decisions." To maintain confidentiality, only the Assistant Director, Programs/PCM and Case Managers have access to screening information.

115.242	Use of screening information

	115.242 (a): The agency uses the information from the risk screening form to make

housing, bed, work, education and program assignments with the goal of separating residents at high risk of being sexually victimized from residents with those at high risk of being sexually abusive. Individualized determinations are made about how to ensure the safety of each resident. GEO policy 5.1.2-A, pages 6 & 7, section D-3 and facility policy 2019-3, page 3, section 2, explains the use of PREA screening information. In interview of the PREA Coordinator he stated, "GEO has developed and implemented a standardized PREA Risk Assessment screening form used at each facility, except for those contractually required to use the client's screening tool. Corporate policy requires each facility to conduct risk assessments on all new intakes within 24 hours of arrival to a facility. Residents who score "at risk", for victimization or abuse are referred for medical and/or mental health assessments as required and tracked on an "At Risk Log", which contains, at a minimum, their status as a potential victim/perpetrator and housing location. The facility's designated PREA Compliance Manager is responsible for reviewing each assessment to ensure proper completion and maintaining the "At Risk Log", to ensure potential victims and abusers are housed separately." Residents who score at risk of victimization or abusiveness are referred to a community provider for further evaluation using the PREA Risk Assessment Referral form. Residents have an option of refusing these services. Those identified to be at risk are tracked on an At-Risk Log. In review of 24 resident records, 10 of the residents scored during initial screening of being at risk for victimization or abusiveness and were found being tracked on the At-Risk Log. One resident was being tracked as a victim, but his screening form indicated a score of being at risk of abusiveness. This information was shared with the Assistant Director, Programs/PCM who revised the At-Risk Log. It was not necessary for the resident's bed assignment to be changed as he was already assigned a bed closer to the door in camera view.

115.242 (b): Individualized determinations on a case-by-case basis are made about how to ensure the safety of each resident. In interview with the Security Monitors and Case Managers, they explained how the facility utilizes screening information from the *Reentry Facilities PREA Risk Assessment Tool* for this purpose. The Assistant Director, Programs/PCM stated male residents who score to be at risk for victimization are assigned beds closer to the door within camera view in a smaller room. Those who score at risk for abusiveness are assigned beds towards the back of the dorm. Female residents who score at risk for victimization or abusiveness are separated within the female dorm.

115.242 (c): Guidelines on housing and program assignments for the management of transgender and intersex residents are outlined in GEO 5.1.2-A policy, pages 6 & 7, section D-3-c-g and facility policy 2019-3, page 3, section 2-d-f. In deciding whether to assign a transgender or intersex resident to a facility for male or female residents, GEO considers on a case-by-case basis whether the placement would ensure the resident's health and safety and whether the placement would present management or security problems. In interview with the PREA Coordinator he stated, "GEO's policy requires each facility to establish a Transgender Care Committee (TCC) consisting of the facility administrator, chief of security, classification or case management supervisor, medical and/or mental health staff

and the PREA Compliance Manager. I may also be consulted as necessary. The TCC must meet as soon as possible but no later than 72 hours after the resident's arrival. In the event the TCC cannot meet immediately, transgender residents may be house in medical during the 72-hour time frame. The TCC is responsible for making all decisions pertaining to housing and program assignments for transgender residents." He further stated, "GEO has developed and implemented a standardized *Transgender Care Committee (TTC) Summary* form used at each facility except for those contractually required to use the client's tool. The TCC considers all information provided from previous confinement facility and/or client, documentation generated upon intake and information noted on the TCC summary to advise housing/program decisions and ensure the residents health and safety. The TCC considers all information provided from the previous confinement facility and/or client, documentation generated upon intake, and information noted on the TCC Summary form to advise housing/program decisions and determine whether placement would present management or security problems."

- 115.242 (d): Transgender and intersex residents' own view of his or her safety is given serious consideration. In interview with the PREA Coordinator he stated, "Transgender and intersex residents are asked whether they have any safety concerns or housing preferences during completion of both the GEO PREA Risk Assessment and Transgender Care Committee Summary. Both documents are utilized to advise housing/program decisions. "
- 115.242 (e): Transgender and intersex residents are asked whether they have any safety concerns or housing preferences during completion of both the *GEO PREA Risk Assessment* and *Transgender Care Committee Summary*. Both documents are utilized to advise housing/program decisions." In interview with the Assistant Director, Programs/PCM, transgender and intersex residents would be offered the opportunity to shower alone at a designated time. In the past 12 months there were no transgender or intersex residents assigned to the CAE.
- 115.242 (f): The agency shall not place lesbian, gay, bisexual, transgender or intersex residents in dedicated facilities, units or wings solely on the basis of such identification or status, unless such placement is in a dedicated facility, unit or wing established in connection with a consent decree, legal settlement or legal judgement for the purpose of protecting such residents. In interview with the PREA Coordinator he stated, "There are no GEO facilities under a consent decree or other legal judgement. GEO policy prohibits housing LGBTI residents in dedicated facilities, units or wings and the facility considers each resident's own views about their safety as part of the initial PREA risk screening assessment. The PREA Compliance Manager maintains an LGBTI Log of residents who choose to disclose their sexual orientation, genital status, or gender identity during intake to track housing locations of LGBTI residents and ensure fair placement." Community Alternatives of El Paso County does not place lesbian, gay, bisexual, transgender or intersex residents in dedicated units or wings solely based on such identification. At the time of the on-site visit, there were no residents who self-disclosed being transgender or intersex housed at the facility. At the time of the onsite audit visit, there were 10 residents who self-disclosed being bisexual and one resident who self-

disclosed being lesbian. In interview of two residents being tracked on the *LGBTI Log*, they both stated they do not feel they were housed any differently because of their sexual orientation.

115.251 Resident reporting

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.251 (a): GEO policy 5.1.2-A, page 14, section L-1 and facility policy 2019-2, page 3, last paragraph outlines the agency/facility's responsibility for providing residents methods of reporting. The agency provides multiple ways for residents to privately report sexual abuse and sexual harassment and retaliation by other residents or staff for reporting sexual abuse and sexual harassment and any staff neglect or violation of responsibilities that may have contributed to such incidents. Residents are made aware of methods of reporting available to them through the PREA Education Manual for Residents (page 9) provided to them upon intake, on the Resident Reporting Options posters and continuously through other PREA information and brochures displayed throughout the facility. Residents are made aware that they can verbally inform any staff member or the Assistant Director, Programs/PCM immediately in person or in writing and a third party can report for them. Residents can also file a grievance and facility policy 2019-5, page 5 addresses sexual abuse grievances and emergency grievance procedures are found on pages 5 & 6. The majority of residents have their own cell phones and the facility has three designated non-pay phones located in the conference room, the male day room and in the hallway of the Tranquility dorm available to residents to call any of the numbers listed on the Resident Reporting Options posters. On the first day of the audit, the number to the Colorado DOC, TESSA and Diversus were dialed on the phone the Tranquility hallway. All numbers were found to be accessible.

115.251 (b): Residents are also informed that they have options to report abuse or harassment to a public or private entity that is not part of GEO. In interview of the PREA Coordinator he stated, "GEO policy requires each facility to provide residents contact information on how to report abuse or harassment to an office that is not part of the agency. At a minimum, facilities provide the contracting agency's reporting line(s) (ICE, USMS, BOP, etc.). Many facilities also provide contact information for local and/or national entities capable of receiving reports of abuse or harassment. GEO policy requires each facility to provide residents contact information to external entities capable of receiving and immediately reporting sexual abuse and harassment to agency officials while allowing the reporting individual to remain anonymous. The agency continually audits each facility for compliance with PREA standards, which includes manual testing of reporting lines to ensure residents are capable of reporting incidents without entering any personally identifiable information. Audits are conducted by facility staff as well as corporate

personnel throughout the year."

Residents are informed on the *Resident Reporting Options* posters they can call the GEO Corporate PREA Office at 561-999-5827 or e-mail them at PREAinfo@geogroup.com. They are also given the address and telephone number to the Colorado DOC TIPS Line and address (1250 Academy Park Loop, Colorado Springs, CO 80910, 855-855-0611). The *Resident Reporting Options* posters also inform residents of the phone numbers and mailing address to TESSA (435 Gold Pass Heights, Colorado Springs, CO 80906, 719-633-3819) and Diversus Health (115 S. Parkside Dr., Colorado Springs, CO 80910, 844-493-8255) and the phone number to RAINN National Advocacy Hotline (800-656-3819). Residents and staff interviewed were aware of resident reporting options available to them and knew reporting anonymously was an option for them.

115.251 (c): Staff must take all allegations of sexual abuse and harassment seriously whether they be made verbally, in writing, anonymously and from third parties and are required to document all reports. Staff interviewed knew the reporting options for residents and knew verbal reports must be documented. Staff who fail to report allegations may be subject to disciplinary action.

115.251 (d): Staff have access to private reporting by calling the Employee Hotline at 866-568-5425 or the Corporate PREA Coordinator at 561-999-5827. They can also report on the agency website at PREAinfo@geogroup.com. Information for resident and staff reporting can be found on the GEO website (http://www.geogroup.com/PREA) under the Social Responsibility tab and clicking on "PREA Certification". Page 4, section I of the Employee Handbook informs employees of their responsibility of reporting sexual abuse and sexual harassment. Staff carry with them a Sexual Abuse First Responder Card, which has the employee hotline number and the website address for anonymous reporting. Third Party Reporting posters were found posted throughout the facility. Staff interviewed were aware of this method of reporting.

115.252 Exhaustion of administrative remedies

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.252 (a): In review of GEO policy 5.1.2-A, pages 14 & 15, section L-2, and facility policy 2019-5, page 5, section E there is a procedure in place for residents to submit grievances regarding sexual abuse and the agency has procedures for dealing with these grievances. Instructions on how to file grievances are provided on pages 8 & 9 of the *PREA Education Manual for Residents*. The Assistant Director, Programs/PCM receives copies of all grievances related to sexual abuse, sexual harassment or sexual activity for monitoring purposes.

115.252 (b): There is no time limit when a resident can submit a grievance

regarding sexual abuse. Residents are not required to use any informal grievance process or attempt to resolve this type of grievance prior to submission. If a third-party file a grievance on a resident's behalf, the alleged victim must agree to have the grievance filed on his behalf.

115.252 (c): Residents have a right to submit grievances alleging sexual abuse to someone other than the staff member who is the subject of the complaint and the grievance will not be referred to a staff member who is the subject of the complaint.

115.252 (d): The agency shall issue a final agency decision on the merits of any portion of the grievance alleging sexual abuse within 90 days of the initial filing of the grievance. The agency may claim an extension of time to respond, of up to 70 days, if the normal time period for response is insufficient to make an appropriate decision.

115.252 (e): Third parties can file grievances relating to allegations of sexual abuse on behalf of a resident. If a third-party file a request on behalf of a resident, the alleged victim must agree to have the request filed on their behalf. If the resident declines to have the grievance processed on his or her behalf, the agency will document the resident's decision.

115.252 (f): Information on emergency grievances is found on page 15, section 2-b of GEO policy 5.1.2-A. An emergency grievance may be filed if a resident feels he is at substantial risk of imminent sexual abuse. After receiving an emergency grievance, the agency will act immediately with corrective action. An initial response will be provided within 48 hours and a final agency decision within five calendar days.

115.252 (g): A resident can be disciplined for filing a grievance related to alleged sexual abuse if it is determined that the resident filed the grievance in bad faith.

The Assistant Director, Programs/PCM receives all copies of grievances relating to sexual abuse or sexual harassment for monitoring purposes. In information provided on the Pre-Audit Questionnaire and in interview with the Assistant Director, Programs/PCM, In the past 12 months, there have been no PREA-related grievances filed. A review of Grievance Log for the past 12 months confirmed there were no PREA-related grievances filed in the past 12 months.

115.253	Resident access to outside confidential support services

	115.253 (a): GEO policy 5.1.2-A, pages 20 & 21I, section M-8 and facility policy 2019-6, page 11, section C-8, addresses the agency's policy on providing residents with access to outside victim advocates for emotional support services related to

sexual abuse. Residents are given the telephone numbers to TESSA and Diversus Health and the telephone to RAINN, the National Sexual Assault Hotline (800-656-4673), where advocates are available 24 hours a day, seven days a week.

115.253 (b): This information is made available to residents on *Resident Reporting Options* posters displayed in various locations throughout the facility and on page 10 of the *PREA Education Manual for Residents*. Residents are informed of the extent to which communications will be monitored and the extent to which reports of abuse will be forwarded to authorities in accordance with mandatory reporting laws.

115.253 (c): The facility has attempted to enter into an MOU with TESSA to provide emotional support services. On 3/26/25 contact was made with the Advocacy Manager of TESSA to discuss services TESSA provides. TESSA has a 24/7 crisis hotline called Safeline. Paid and volunteer advocates and interns answer Safeline calls, after they complete 35 hours of Victim Advocacy training. Calls to Safeline are not recorded and callers can remain anonymous upon request. A contract with Language Line Solutions provides translation for non-English speaking callers. If a caller reports an allegation of sexual abuse, the advocate will walk the caller through options of self-reporting. TESSA provides advocates to accompany victims through the forensic exam procedure. An advocate is available at the UC Health Hospital during normal business hours. After hours Safeline is called for call-out availability of an advocate to be dispatched to the hospital. Follow-up services are provided within 24-48 hours after the forensic exam and again one month later. TESSA has a clinical team comprised of Social Workers and Psychologist for further follow-up as needed. There is also an advocate at the courthouse during business hours to help victims fill out paperwork related to Orders of Protection. All services are confidential and provided at no cost to the victim.

When interviewed, residents were aware there were outside confidential support services available to them, but did not know the name of the agency. One resident interviewed was familiar with TESSA because he had used their services in the past.

Auditor Overall Determination: Meets Standard Auditor Discussion 115.254 (a): Based on GEO policy 5.1.2-A, page 15, section L- 3, the agency has a method to receive third-party reports of sexual abuse and sexual harassment on behalf of individuals in a GEO facility or program. Information on third-party reporting was posted in the facility in English and Spanish and is made available on the GEO website at http://www.geogroup.com/PREA (Social Responsibility-PREA Certification Section). Third-party reports can be made in person, in writing,

anonymously or by contacting the agency's PREA Coordinator. Residents and staff interviewed were aware of this method of reporting.

During the past 12 months, there have been no reports of sexual abuse or sexual harassment made to the facility by a third party.

115.261 Staff and agency reporting duties

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.261 (a): The agency's requirement on staff reporting duties can be found pages 15 & 16, section L-4 of GEO policy 5.1.2-A and facility policy 2019-6, pages 6 & 7, section III-B. Employees must take all allegations of sexual abuse and sexual harassment seriously. All staff are required to report immediately to the Facility Director or to the Assistant Director, Programs/PCM any knowledge, suspicion or information regarding an incident of sexual abuse or sexual harassment and any retaliation against residents or staff who reported such an incident and any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation. All allegations of sexual abuse and sexual harassment, including third party and anonymous reports, are reported to supervisors. The supervisor receiving the report immediately notifies the Facility Director. The Facility Director notifies the El Paso County Community Corrections Administrator and the Division of Criminal Justice, Office of Community Corrections. If an allegation involves staff, notification is also made to GEO's OPR.

115.261 (b): Apart from reporting to designated supervisors, staff shall not reveal any information related to a sexual abuse report to anyone other than to the extent necessary to make treatment, investigation and other security and management decisions. Staff interviewed confirmed this practice.

115.261 (c): CAE does not have medical or mental health staff; therefore, this provision of the standard is not applicable to this facility.

115.261 (d) The CAE houses adult male and female residents, none of whom according to their classified level of care are considered vulnerable adults under the State Vulnerable Persons Statue, as verified by interview with the Facility Director. If there is an allegation of a vulnerable adult, facilities are instructed to contact state or local service agencies under mandatory reporting laws. In interview with the Facility Director, he stated he would contact the Colorado Springs Police Department, if necessary for information on mandatory reporting laws. Interview of the PREA Coordinator he stated, "Unless precluded by federal or local law, medical and mental health practitioners are required to report allegations of sexual abuse for alleged victims under the age of 18 or considered a vulnerable adult to

designated state or local service agencies under applicable mandatory reporting laws."

115.261 (e): All allegations of sexual abuse and sexual harassment, including thirdparty and anonymous reports, are reported to the facility investigators or to the Colorado Springs Police Department.

115.262 Agency protection duties

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.262 (a): When the agency learns that a resident is subject to a substantial risk of imminent sexual abuse, it takes immediate action to protect the resident according to GEO policy 5.1.2-A, page 16, section M-1 and facility policy 2019-6, page 7, section C-1. In interview with the Director, Quality Assurance and Reentry Services (Agency Head Designee) he stated, "The agency takes immediate action to protect the victim from further harm and refers the resident for necessary offsite services (medical, mental health, etc.)."

In interview with the Facility Director and in information provided on the Pre-Audit Questionnaire, there were no times during the past 12 months that it was necessary for the agency to take immediate action in regard to a resident being in substantial risk of sexual abuse. Staff interviewed were aware of their responsibilities if they felt a resident was at risk for sexual abuse.

115.263 Reporting to other confinement facilities

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.263 (a): GEO policy 5.1.2-A, pages 19 & 20, section M-5 and facility policy 2019-6, pages 9 & 10, section C-5, were used to verify compliance to this standard. Upon receiving an allegation that a resident was sexually abused while confined at another facility, the allegation will be documented and the Facility Director or his designee shall notify the head of the facility where the sexual abuse was alleged to have occurred and document that notification was provided. This notification is to occur as soon as possible, but no later than 72 hours of receiving the allegation and should include all actions taken regarding the incident. Copies of this documentation will be forwarded to the PREA Coordinator and the Assistant Director, Programs/PCM.

115.263 (b): In interview with the Facility Director and in review of documentation

provided, in the past 12 months, there were no residents of the CAE who alleged that sexual abuse had occurred while they were confined to another facility. During this reaccreditation period (2023) there was one resident who alleged sexual abuse while confined to another facility. Documentation was provided for review of the notification the Facility Director made to the Warden of the of the other facility.

115.263 (c): The agency shall document that notification was provided. Copies of this documentation are forwarded to the agency's PREA Coordinator.

115.263 (d) If a report is received from another facility regarding alleged sexual abuse occurring at CAE, the allegation will be reported and investigated according to PREA standards. In interview with the Facility Director and on information reported on the Pre-Audit Questionnaire, in the past 12 months, there were no allegations of sexual abuse received from other facilities. In interview with the Director, Quality Assurance and Reentry Services (Agency Head Designee) he stated, "When a facility receives such an allegation, the allegation will be referred to designated investigators (internal or external) for investigation. GEO's PREA Coordinator is also informed of all allegations of this type via email."

115.264 Staff first responder duties

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.264 (a): GEO policy 5.1.2-A, pages 16 - 19, section M-2, and facility policy 2019-6, pages 8 & 9, section C-3, outlines the procedure for first responders to follow for allegations of sexual abuse and sexual harassment whether that person is a security or non-security staff member. Per policy, upon learning of an allegation of sexual abuse, the first security staff member to respond to the report is to separate the alleged victim and abuser, immediately notify the on-duty or on-call supervisor, preserve and protect the crime scene, not let the alleged victim or abuser take any actions that could destroy physical evidence and not reveal to anyone information related to the incident to anyone other than staff involved with investigating the alleged incident.

115.264 (b): If the first responder is not a security staff member, the responder is to request that the alleged victim not take any actions that could destroy physical evidence and notify security staff. All staff carry with them a *Sexual Abuse First Responder Card* affixed to their badges reminding them of the steps to take if they are the first responders to an allegation of sexual abuse or sexual harassment. Random interviews with security and non-security staff revealed that they knew the policy and practice to follow if they were the first responder to an allegation of sexual abuse or sexual harassment. They reported that they knew that the alleged victim and abuser must be separated and knew how to preserve the crime scene and the physical evidence. On information provided on the Pre-Audit Questionnaire, in the past 12 months, there were two allegations of inmate-on-inmate sexual abuse

reported, and first responder duties were not required for either case. Staff are informed of their first responder duties during Pre-Service and in annual In-Service PREA training.

115.265	Coordinated response

	115.265 (a): GEO policy 5.1.2-A, page 2, section II-A-4 and in review of the CAE's <i>PREA Coordinated Response Plan</i> were used to verify that there is a plan in place to coordinate actions to be taken in response to an incident of sexual abuse. The plan provides written guidance to staff and administration regarding actions to take and notifications to be made. A <i>PREA After-Action Checklist for Incidents of Sexual Abuse and Harassment</i> is completed to ensure that all steps of the plan and proper notifications are made. This checklist is filed with the completed investigative packet. The Facility Director is responsible to ensure compliance to the plan. Staff interviewed confirmed they are knowledgeable of the plan and the necessary actions to be taken in response to an allegation of sexual abuse.

Preservation of ability to protect residents from contact with 115.266 abusers Auditor Overall Determination: Meets Standard **Auditor Discussion** 115.266 (a): GEO policy 5.1.2-A, page 2, section II-A-5, and facility policy 2019-6, pages 4 & 5, section C-2, were used to verify compliance to this standard. GEO would not enter into a collective bargaining agreement or other agreements that would limit the agency's ability to remove an alleged staff sexual abuser from contact with any resident pending the outcome of an investigation. In interview with the Director, Quality Assurance and Reentry Services (Agency Head Designee), he stated, "The Reentry Services division currently has three facilities which have a collective bargaining agreement: Delaney Hall (NJ). Tully House (NJ), and The Harbor (NJ). None of the languages in the collective bargaining agreement precludes investigations and disciplinary action against staff, up to and including termination for substantiated allegations of sexual abuse and sexual harassment." On information provided for review, the CAE does not have a collective bargaining agreement. 115.266 (b): In all cases where the alleged abuser is an employee, contractor or a volunteer, there will be no contact between the alleged abuser and the alleged victim pending the outcome of an investigation. The staff member will be

reassigned to a post with no resident contact or placed on administrative leave pending completion of the investigation.

115.267 Agency protection against retaliation

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.267 (a): GEO has as policy to protect residents who report sexual abuse or sexual harassment or cooperate with sexual abuse or sexual harassment investigations from retaliation by other residents or staff as outlined in policy 5.1.2-A, pages 21 & 22, section N-2 and in facility policy 2019-6, pages 12 & 13, section C-9-2. In the past 12 months there were two allegations of inmate-on-inmate sexual abuse reported.

115.267 (b): The agency has multiple protection measures, such as housing changes or transfers for residents, victims or abusers, removal of alleged staff or resident abusers from contact with victims and emotional support services for residents or staff that fear retaliation for reporting sexual abuse or sexual harassment or for cooperating with investigations. If any other individual who cooperates with an investigation expresses a fear of retaliation, appropriate measures to protect that individual against retaliation are put in place. According to the Director, Quality Assurance and Reentry Services (Agency Head Designee), "When a PREA incident is reported, management staff, on a case-by-case basis, consider the best options for the victim like housing changes or transfers from the facility, removal of alleged abusers, whether staff or resident, and emotional support services."

115.267 (c): The Assistant Director, Programs/PCM, Case Manager Supervisor or IRT Case Manager are responsible for weekly monitoring for retaliation for at least 90 days and longer if there is a continuing need. Monitoring is documented on the Protection from Retaliation Log for residents and employee monitoring is documented on the Employee Protection from Retaliation Log. In review of investigative files of those allegations, retaliation monitoring forms were found filed in the respective files. On alleged victim was monitored weekly for six weeks following the report of the allegation before he escaped. The other alleged victim escaped three days after the allegation was reported. A monitoring form was prepared and filed with a notation with the date the resident escaped. In the past 12 months, there were no incidents of retaliation that occurred. When interviewed, staff members responsible for monitoring knew their responsibilities for monitoring for retaliation per policy.

115.271 Criminal and administrative agency investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.271 (a): An administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment at the CAE, including third party and anonymous reports. The agency's policy on administrative and criminal investigations is outlined in GEO policy 5.1.2-E, pages 2-4, section II-B-1. Investigations of sexual abuse and sexual harassment are required to be investigated promptly, thoroughly and objectively as stated on page 3, section B-d of GEO policy 5.1.2-E. The supervisor receiving the report of an allegation of sexual abuse or sexual harassment immediately notifies the Facility Director who notifies the PREA Coordinator and the Director, Fidelity & Assurance and the clients prior to investigating all allegations of sexual abuse and sexual harassment. If the allegation involves a staff member, notification is made to GEO's OPR. All allegations of sexual abuse and sexual harassment are documented on the Monthly PREA Incident Tracking Log. In interview of facility investigators, they confirmed when allegations are reported they immediately initiate an investigation. They also confirmed that anonymous and third-party allegations are also immediately investigated. In the past 12 months and since the last PREA audit, there were two allegations of inmate-on-inmate sexual abuse reported and administratively investigated.

- 115.271 (b): The Assistant Director, Programs/PCM and the Assistant Director, Security are the trained facility investigators responsible for conducting administrative investigations. The facility provided certificates of completion of specialized investigation training for facility investigators. When interviewed, investigators confirmed completing specialized investigation training and were able to describe some of the topics addressed in the training.
- 115.271 (c): The investigators gather and preserves direct and circumstantial evidence, including physical and DNA evidence and available electronic monitoring data. In interview of investigators, they reported they interview the alleged victims, suspected perpetrators and witnesses and review prior complaints and reports of sexual abuse involving the suspected perpetrator. The Assistant Director, Security was not interviewed as she was out sick. When interviewed the Assistant Director, Programs/PCM stated she would gather statements, camera footage, pictures and phone data.
- 115.271 (d): The Colorado Springs Police Department conducts criminal investigations of sexual abuse. Facility investigators stated during interview if an allegation appears to be criminal, they will consult with prosecutors before conducting compelled interviews. The facility has made attempts to secure an MOU with the Colorado Spring Police Department. To date those efforts have been unsuccessful. On 3/21/25, the Sargeant of the Special Victims Unit of the Colorado Springs Police Department was contacted to discuss the process in the event of a sexual assault at the Community Alternatives of El Paso facility. The facility is located in the jurisdiction of the Police Department and are responsible for

investigating all crimes that occur in their jurisdiction. When notified of a sexual assault, a Patrol Officer would be dispatched to the facility to gather information for an initial report. Depending on the level of the offense would depend on how the Police Department proceeds. If the assault involved staff, a detective from the Special Victims Unit would definitely be assigned to investigate the allegation. In the case of an allegation of resident-on-resident sexual abuse, their response would be determined by the facts of the case. Victims of sexual abuse would be transported to Memorial Hospital for a SANE exam. Every 60 days the detective assigned to the case would contact the victim to inform him/her of the status of the investigation. The facility can contact the detective at any time. A copy of the completed criminal investigative report can be requested through the Public Information Act.

- 115.271 (e): The credibility of an alleged victim, suspect or witness is assessed on an individual basis and is not determined by the person's status as resident or staff. A resident who alleges sexual abuse is not required to submit to a polygraph examination. GEO retains all written reports pertaining to administrative investigations of sexual abuse and sexual harassment for as long as the alleged abuser is incarcerated or staff member is employed by the agency, plus five years.
- 115.271 (f): The administrative investigation will include an effort to determine whether staff actions or failures to act contributed to the abuse. The administrative investigation shall be documented in a written report and include a description of the physical and testimonial evidence, the reasoning behind credibility assessments and investigative facts and findings.
- 115.271 (g): A criminal investigation shall be documented in a written report that contains a thorough description of physical, testimonial and documentary evidence. The facility can request a copy of the completed investigative report from the Colorado Springs Police Department. Upon receipt, the report will be forwarded to the corporate PREA Manager.
- 115.271 (h): Substantiated allegations of conduct that appears to be criminal will be referred for prosecution. Since the last PREA audit, there were no substantiated allegations of sexual abuse that were referred for criminal investigation.
- 115.271 (i): GEO retains all written reports pertaining to administrative investigations of sexual abuse and sexual harassment for as long as the alleged abuser is incarcerated or staff member is employed by the agency, plus five years, but the files shall be retained for no less that ten years.
- 115.271 (j): The departure of the alleged abuser or victim from the employment or control of the facility or agency shall not provide a basis for terminating an investigation. Facility investigators interviewed confirmed this practice.
- 115.271 (k): Any state entity or Department of Justice component that conducts such investigations shall do so pursuant to the above requirements. This provision is not applicable to this agency/facility.

115.271 (I): The facility shall cooperate with outside investigators and remain informed of the progress of the investigation through communication with outside investigators. In interview of the agency's PREA Coordinator he stated, "Facilities are instructed to request an update from the outside law enforcement entity at least monthly to track the status of the investigation. The investigation outcome affects monitoring for retaliation, inmate notices of outcomes, and sexual abuse incident reviews. Generally, the facility directors have developed great working relationships with these entities so there is regular dialogue about the status of open investigations." In interview the Facility Director stated he would call the police department to stay informed of the status of the investigation.

Auditor Overall Determination: Meets Standard Auditor Discussion 115.272 (a): Based on GEO policy 5.1.2-E, pages 4 & 5, section B-2-d, the agency/ facility shall impose no standard higher than the preponderance of evidence in determining whether allegations of sexual abuse or sexual harassment are substantiated. When the Assistant Director, Programs/PCM was asked what standard of evidence was used in determining if an allegation is substantiated, she confirmed the agency policy. In review of the investigative files of the two allegations reported in the past 12 months, in the Summary of Investigative Findings section of the reports, both reports stated, "Based on the preponderance of the evidence, the investigation determined the allegation of a violation of GEO's PREA policy 5.1.2; Inmate-on-Inmate Sexual Abuse is unsubstantiated."

Auditor Overall Determination: Meets Standard Auditor Discussion 115.273 (a): GEO policy 5.1.2-E, page 9, section K was used to verify compliance to this standard. The policy indicates that following an investigation of sexual abuse of a resident, the resident shall be informed as to whether the allegation has been determined to be substantiated, unsubstantiated or unfounded. The Assistant Director, Programs/PCM is responsible to present to the resident the Notification of

Outcome of Allegation form, which the resident signs. The resident is given the original form, and a copy of the form is retained in the investigative file of the corresponding PREA incident. In the past 12 months, there were two allegations of inmate-on-inmate sexual abuse reported. In review of the investigative files of the two investigations, Notification of Outcome of Allegation forms were prepared and found filed in the investigative files, but they were not presented to the alleged victims because both residents escaped prior to the completion of the investigations.

115.273 (b): If the facility did not conduct the investigation, the facility shall request the relevant information from the investigative agency in order to inform the resident.

115.273 (c): The policy further states that following a resident's allegation that an employee has committed sexual abuse against the resident the facility is required to inform the resident of the outcome of the investigation, unless the facility has determined that the allegation was unfounded.

115.273 (d): Following a resident's allegation that another resident sexually abused him, the agency shall inform the resident of the outcome of the investigation. The facility's obligation to notify the resident shall terminate if the resident is released from custody. A *Notification of Outcome of Allegation* form must still be completed and retained in the investigative file.

115.273 (e): All notifications or attempted notifications are documented and retained in the corresponding investigation file. Based on interview with the Assistant Director, Programs/PCM, the process of providing notification to resident victims at the conclusion of an investigation is in place and being followed.

115.276 Disciplinary sanctions for staff

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.276 (a): Employees shall be subject to disciplinary sanctions up to and including termination for violating agency sexual abuse policy as outlined in policy GEO policy 5.1.2-E, pages 9 &10, section L-1. The GEO Employee Handbook is provided to all staff. Page 18 of the GEO Employee Handbook explains the zero-tolerance policy for employees.

115.276 (b): Termination shall be the presumptive disciplinary sanction for staff who have engaged in sexual abuse.

115.276 (c): According to GEO policy 5.1.2-E, page 10, section L-1-c, disciplinary sanctions for violations of agency policies relating to sexual abuse or sexual harassment (other than actually engaging in sexual abuse) shall be commensurate

with the nature and circumstances of the acts committed, the staff member's disciplinary history, and the sanctions imposed for comparable offenses by other staff with similar histories.

115.276 (d): All terminations for violations of the agency's policies on sexual abuse and sexual harassment, or resignations, shall be reported to law enforcement and licensing agencies unless the activity was clearly not criminal. In information provided on the Pre-Audit Questionnaire, in the past 12 months, no staff has been disciplined or terminated for violating the agency's sexual abuse or sexual harassment policy.

115.277 **Corrective action for contractors and volunteers** Auditor Overall Determination: Meets Standard **Auditor Discussion** 115.277 (a): Based on review of GEO policy 5.1.2- A, page 12, section H-4 and policy 5.1.2-E, page 10, section L-3, any volunteer or contractor who engages in sexual abuse is prohibited from contact with residents and shall be reported to law enforcement agencies and licensing boards, unless the activity was clearly not criminal. 115.277 (b): The facility shall take appropriate remedial measures and shall consider whether to prohibit further contact with residents, in the case of any other violation of agency sexual abuse or sexual harassment policies by a contractor or volunteer. The facility has seven volunteers and two contractors. According to information reported on the Pre-Audit Questionnaire and in interview with the Facility Director, in the past 12 months there were no volunteers or contractors who violated the zero-tolerance policies. If a volunteer or contractor violates the zerotolerance policies, the Facility Director stated, the person would no longer be allowed access to the facility.

Auditor Overall Determination: Meets Standard Auditor Discussion 115.278 (a): According to facility GEO policy 5.1.2-E, page 10, section L-2, if a resident is found guilty of engaging in sexual abuse involving other individuals in a GEO facility shall be subject to formal disciplinary sanctions. Residents are made aware of prohibited acts they will be disciplined for, and the sanctions imposed in

the Resident Handbook, Chapter 2, Section 202, addresses prohibited acts of sexual misconduct and the sanctions that will be imposed for violation of these acts.

115.278 (b): According to policy, sanctions will be commensurate with the nature and circumstances of the abuse committed, the individual's disciplinary history and the sanctions imposed for comparable offenses by other individuals with similar histories. In interview with the Facility Director, he stated a meeting with managers would be held to discuss.

115.278 (c): Based on GEO policy 5.1.2-E, page 11, section 2-c, the disciplinary process may consider whether an individual's mental disabilities or mental illness contributed to his or her behavior when determining what type of sanction, if any, should be imposed.

115.278 (d): The offending resident will be referred offsite to participate in counseling or other interventions designed to address the reasons or motivations for the abuse.

115.278 (e): Disciplining an offender for sexual contact with an employee is prohibited unless it is found that the employee did not consent to the contact. The agency prohibits all sexual activity between residents.

115.278 (f): A report of sexual abuse made in good faith based upon a reasonable belief that the alleged conduct occurred shall not constitute falsely reporting an incident of lying, even if an investigation does not establish evidence sufficient to substantiate the allegation.

115.278 (g): Facilities may not deem that sexual activity between individuals in a GEO facility is sexual abuse unless it is determined that the activity was coerced.

On information provided on the Pre-Audit Questionnaire and in interview with the Facility Director, in the past 12 months, there were no disciplinary sanctions imposed related to resident sexual misconduct.

115.282 Access to emergency medical and mental health services

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.282 (a): Victims of sexual abuse receive timely, unimpeded access to emergency medical treatment and crisis intervention services as stated in GEO policy 5.1.2-A, page 20, section M-7 and facility policy 2019-6, page 11, section C-7. Victims of sexual abuse would be transported to Memorial Central Hospital Emergency Department for a SANE exam. Crisis intervention services are provided by TESSA.

115.282 (b): The Community Alternatives of El Paso County does not employ

medical or mental health practitioners. According to GEO policy, reentry community confinement facilities shall utilize local community facilities to provide emergency medical treatment and crisis intervention if onsite medical and mental health providers are not available. Following a reported PREA allegation, a *Resident Referral Verification* form is used to document the offer for offsite mental health services were offered to the resident victim. The resident victim has an option of accepting or declining these services.

115.282 (c): Resident victims of sexual abuse are offered timely information about and timely access to emergency contraception and sexually transmitted infections prophylaxis, in accordance with professionally accepted standards of care, where medically appropriate. In conversation with the Clinical Manager of the Forensic Nurse Examiner Team at the Memorial Central Emergency Department, it is the standard of practice for the alleged victim be offered STD prophylaxis. Female victims are given a pregnancy test and offered emergency contraception.

115.282 (d): All services provided are at no cost to the alleged victim, regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident. In conversation with the Clinical Manager of the Forensic Nurse Examiner Team at the Memorial Central Emergency Department, she stated all services provided are at no cost to the alleged victim.

On information provided on the Pre-Audit Questionnaire and in interview of the Facility Director, in the past 12 months, it was not necessary for any residents to be referred for emergency medical or crisis intervention services.

115.283

Ongoing medical and mental health care for sexual abuse victims and abusers

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.283 (a): According to GEO policy 5.1.2-A, page 21, section N-1, CAE will offer ongoing medical and mental health care to all the residents who have been victimized by sexual abuse.

115.283 (b): The evaluation and treatment will include follow-up services, treatment plans and referrals for continued care upon transfer or release.

115.283 (c): Medical and mental health services are provided by referral to community providers. Resident victims are offered ongoing medical treatment at the Memorial Central Hospital and mental health services at TESSA. Additional services are available by referral to Recovery Unlimited or Diversus. The *Resident Referral Verification* form is used to document the offer for mental health services. The resident victim has an option of accepting or declining these services.

115.283 (d): Female victims of sexually abusive vaginal penetration are offered pregnancy tests. In conversation with the Clinical Manager of the Forensic Nurse Examiner Team at the Memorial Central Emergency Department, pregnancy tests are performed on all female victims of childbearing age.

115.283 (e): If pregnancy results, the victim shall receive timely and comprehensive information about access to all lawful pregnancy-related medical services and given a prescription for contraception prophylaxis. This practice was confirmed in conversation with the Clinical Manager of the Forensic Nurse Examiner Team at the Memorial Central Emergency Department.

115.283 (f): All resident victims are given a prescription for STD prophylaxis.

115.283 (g): All services will be provided without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

115.283 (h): The facility attempts to conduct a mental health evaluation of all known abusers within 60 days of learning of such abuse history and offers treatment when deemed appropriate. Mental health services are provided by referral to TESSA, Recovery Unlimited or Diversus.

In the past 12 months, there were no residents who required ongoing medical or mental health treatment due to being victimized by sexual abuse.

115.286 Sexual abuse incident reviews

Auditor Overall Determination: Meets Standard

Auditor Discussion

115.286 (a): GEO policy 5.1.2-A, page 23, section N-3 and facility policy 2019-6, pages 13 & 14, section C-9-3, state the facility is required to conduct a sexual abuse incident review at the conclusion of every sexual abuse investigation in which the allegation has been determined to be substantiated or unsubstantiated.

115.286 (b): The review is to be conducted within 30 days of the conclusion of the investigation. There were two incident reviews conducted in this reaccreditation period. In the past 12 months there were two allegations of inmate-on-inmate sexual abuse reported and administratively investigated. In review of the investigative files of those allegations, incident reviews were conducted within 30 days of the conclusion of the investigations.

115.286 (c): The Incident Review Team consists of the Facility Director, Assistant Director, Programs/PCM, Assistant Director, Security and the Program Fidelity Specialist, with the PREA Coordinator sometimes consulted as part of the review.

115.286 (d): The review team considers whether the incident was motivated by

race, ethnicity, gender identity, perceived status or gang affiliation. The team examines the area where the incident was alleged to have occurred and assesses whether physical barriers in the area may have contributed to the abuse, whether monitoring technology should be deployed or augmented and whether the staffing levels at the time of the incident were adequate. In interview with Incident Review Team members, they were knowledgeable of their responsibilities in review of sexual abuse allegations determined to be substantiated or unsubstantiated. Incident reviews are documented on a *PREA After Action Review Report* (attachment J to policy 5.1.2-A) with any recommendations for improvement and forwarded to the PREA Coordinator no later than 10 working days after the review. The Assistant Director, Programs/PCM maintains copies of all completed PREA After Action Review Reports and a copy is retained in the corresponding investigative file.

In interview with the agency's PREA Coordinator he stated, "Each facility is required to complete the GEO PREA After Action Review Report within 30 days of case closure. Each review includes an examination of the five questions outlined in the standard and capture any recommendations made or corrective actions taken. Furthermore, the report includes an analysis of the actions taken by staff and whether those actions complied with the corporate, facility and contracting agency's PREA policies. The PREA Compliance Managers at each facility are required to upload PREA After Action Review Reports to the agency's secure portal within 30 days of case closure. The corporate PREA Compliance Team monitor these reports and work with the facility to address issues as necessary. If an after-action report necessitates corrective action at the corporate level, the PREA Coordinator works with the applicable department heads to implement appropriate measures. To date, no systemic trends have been identified. The corporate PREA compliance teal reviews this data annually to determine the improvements needed to enhance our PREA program. I review the recommended improvements and submit my recommendations to the divisional authority for reentry for review and approval."

115.286 (e): The facility will implement the recommendations for improvement or document the reasons for not doing so.

115.287	Data collection
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	115.287 (a) & (c): Information on data collection is found on page 23, section O-1 of GEO policy 5.1.2-A. GEO collects uniform data for every allegation of sexual abuse at all facilities under their control. The incident-based data collected shall include, at minimum, the data necessary to answer all questions from the most recent version of the Survey of Sexual Violence conducted by the Department of Justice.
	115.287 (b): The Assistant Director, Programs/PCM ensures that the data is

compiled and forwarded to the PREA Coordinator on a monthly basis on the Monthly PREA Incident Tracking Log (attachment K of policy 5.1.2-A). In addition to submitting the Monthly PREA Incident Tracking Log, the Assistant Director, Programs/PCM is to ensure that a PREA Survey is created, updated and submitted for review and approval in the PREA Portal for every allegation of sexual abuse, sexual harassment and sexual activity. At least annually, the PREA Coordinator aggregates this data.

115.287 (d): The agency shall maintain, review, and collect data as needed from all available incident-based documents, including reports, investigation files, and sexual abuse incident reviews.

115.287 (e): This provision of this standard is not applicable to this facility. The agency does not contract for the confinement of its residents.

115.287 (f): Upon request, GEO shall provide such data from the previous calendar year to the Department of Justice no later than June 30. This information was requested from DOJ for the previous year.

115.288 Data review for corrective action

Auditor Overall Determination: Exceeds Standard

Auditor Discussion

115.288 (a): Based on GEO policy 5.1.2-A, pages 23 & 24, section O-2, the agency reviews all of the data collected from all of its facilities and aggregates that data annually to assess and improve the effectiveness of its sexual abuse prevention, detection and response policies, practices and training by identifying problem areas, taking corrective action on an ongoing basis and preparing an annual report of its findings. In interview the PREA Coordinator he stated, "All of GEO's clients with the exception of the USMS, include GEO PREA data in their annual PREA reports. Each facility is required to complete the *GEO PREA After Action Report* after each substantiated or unsubstantiated case. Any recommendations for improvement, problem areas identified, or corrective actions need are documented and captured in the facility's Annual PREA Facility Assessment."

115.288 (b): The PREA Coordinator reviews the data collected and the annual report includes a comparison of the current year's data and corrective actions with those from prior years and provides an assessment of the agency's progress in addressing sexual abuse. In interview of the PREA Coordinator he stated, "GEO publishes a PREA report annually. Currently, annual PREA data reports from 2017-2023 are available on GEO's website." The PREA Coordinator further stated, "The corporate PREA team reviews this data annually to determine the improvements needed to enhance the overall PREA program. These recommended improvements are submitted to the divisional authority for reentry annually for reviews and approval."

115.288 (c): The PREA Coordinator forwards the annual report to the Senior Vice President of GEO Care and to the Senior Vice President, US Corrections and Detention and International Operations for their signatures and approval. The report is made public on the GEO website at https://www.geogroup.com/prea. PREA Annual Reports from 2017-2023 were found posted on the GEO website.

115.288 (d): Before making aggregated sexual abuse data public, all personal identifiers are redacted as stated on the last page of GEO's Annual PREA Report. In interview of the PREA Coordinator he stated, "GEO only reports statistical data and incident types. Personally identifiable information is excluded for confidentiality purposes."

The Annual PREA Reports provide an excellent overview of the agency's efforts in the prevention of sexual abuse and sexual harassment in its facilities and therefore, exceed in the requirements of this standard.

115.289 Data storage, publication, and destruction Auditor Overall Determination: Meets Standard

Auditor Discussion

115.289 (a): Based on GEO policy 5.1.2-A, page 29, section O-3, GEO ensures that data collected are securely retained for at least 10 years according to GEO policy 1.1.7-A (11). In interview with the PREA Coordinator he stated, "GEO maintains a secure PREA portal with restricted access to retain all PREA related data. Every sexual abuse incident and documentation pertaining to said incident is entered into the portal by the PREA Compliance Manager at each facility. The corporate PREA compliance team, to include myself, have access to this portal."

115.289 (b): GEO makes all aggregated sexual abuse data from all its facilities made public annually on their website at https://www.geogroup.com/prea. In review of the agency website, Annual PREA Reports for 2017-2023 were found posted on the agency's website.

115.289 (c): Before making aggregated sexual abuse data public, all personal identifiers are redacted, as stated on the last page of GEO's Annual PREA Reports.

Calls to Safeline are not recorded and callers can remain anonymous upon request. A contract with Language Line Solutions provides translation for non-English speaking callers. If a caller reports an allegation of sexual abuse, the advocate will walk the caller through options of self-reporting. TESSA provides advocates to accompany victims

through the forensic exam procedure. An advocate is available at the UC Health Hospital during normal business hours. After hours Safeline is called for call-out availability of an advocate to be dispatched to the hospital. Follow-up services are provided within 24-48 hours after the forensic exam and again one month later. TESSA has a clinical team comprised of Social Workers and Psychologist for further follow-up as needed. There is also an advocate at the courthouse during business hours to help victims fill out paperwork related to Orders of Protection. All services are confidential and provided at no cost to the victim.
